## CONCERNING THE "MORMONS" IN IDAHO.

BRIGHAM CITY, Utah, Oct. 24th, 1890. Editor Deseret News;

"Would you please inform me, through the columns of your paper, on the following points:
"What are the rights that the 'Mor-

mon' population in Idaho are decrived

of?
"When was citizenship, other rights above mentioned taken from them, and by what laws and

processes?
"Was it through the workings of the Republican party that the 'Mor-mons' were deprived of these rights?

"By giving me information on the above matters you would greatly oblice. N. A."

The rights of which the "Mormons" in Idaho have been deprived, are those political rights which are exercised by all citizens of the United States over twentyone years of age in that Territorythe right to vote, to hold office and trine and policy, others, for place or

to sit on juries. These are denied them by the Constitution of the State of Idaho. Membership ln a certain church or association is made the test of political disability.

"Citizenship" is not taken from any person, either in Idaho or elsewhere, by law or constitution. It is certain rights and privileges that grow out of citizenship which have heen taken from the "Mormons" of Idaho. Those who have thus been stripped of political power are still citizens of the United States and of the State of Idaho. Their citizenship cannot be taken away.

The right to vote and to hold office was wrested from the Idaho "Mormons" by the enactment of the test oath, which, with the history of its passage, will be regarded as the most infamous blot that appears upon the annals of Idaho. It was passed by the Territorial Legislature in December 1884. Its validity was upheld by the courts of the Territory, and finally by the Supreme Court of the United States, the last named judicial body mistaking the grounds upon which objection to it was made, and incorporating in its opinion, as arguments of counsel, sentiments they neither expressed or entertained.

At the election in Idaho of 1888. a number of "Mormons" who had withdrawn from the Church for the purpose of voting, being able to declare truthfully that they were not members of that church or association, were denied the right to vote notwithstanding such withdrawal. And some who cast their votes were prosecuted for doing so. A number of these cases are still pending, as it was alleged that their withdrawal. was not actual but only pretended. Thus, whether members of the proscribed church or not, citizens were denied the right of the exercise of the suffrage, because of their affiliation or supposed sympathetic connection with the "Mormon" Church, which is tantamount to disfranchisement and punishment for belief.

The Republican party is chiefly responsible for these encroachments upon constitutional principles and privileges. But if it had not been for some two-faced and treacherous pretended Democrats, the infamy could never have been consummated. The Democratic party in Idaho could have prevented the wrong if the party had been sincere, whole-hearted and courageous. But while some of its members stood up manfully for sound Democratic doc-
