Scarc.—We have not had many "two-thirds republican" dispatches over the wires to-day.

Arrived.—We learn, from Brother John N. Pike, that Elder Henry Grow and accompanying missionary party arrived at Philadelphia on Monday morning, all well.

Another.—Mr. Jas. B. McKean's organ adds still another to the numerous pet names his admirers have applied to him. Now it calls him the "overthrown jurist." There must be a famine for compliments if that is to be considered as one.

Home-Made Blacking.—Messrs. R. Matthews & Co. are manufacturing a very good article of blacking. Besides it giving a strong lustre to the leather, it keeps it soft and helps it to resist the action of water.

The Election in the City.—The election in this city went off in peace, good order and quietude from the opening to the closing of the polls, and not a single arrest was made. The special deputies appointed by the United States Marshal deported themselves in a gentlemanly and respectful manner, confining themselves to their own particular duties, without infringing upon the rights of anybody, and the supervisors, judges and other officials conducted matters fairly and courteously. The lovers of good order cannot but be gratified at the satisfactory manner in which affairs passed off yesterday.

Quiet and Peaceable.—The following was received to-day—

WEST JORDAN PRECINCT, Salt Lake County, November 7th.

The election passed off very quietly here to-day, the "People's Ticket" being the only one polled. Not only the "Mormon" electors turned out en masse, but many who are not "Mormons" came forward and supported Hon. George Q. Cannon, with their votes, and all seemed to be well satisfied with him as a Delegate.

Centennial Relief.—An old dinner plate, of much interest, has been received at the Deseret Museum. In the center is the well known constitutional expression:

"Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech; or the right of the people peaceably to assemble and to petition the government for a redress of grievances." CONSTITUTION U. S.

On the margin of the plate are esoteric and devices. The upper one represents a primitive printing press, from which the Genius of Liberty is distributing copies of the Constitution, surrounded by the legend, "The Tyrants Foe, the People's Friend." The other esoteric designs contain, respectively, the scales of justice; "We hold that all men are created equal; of one blood are all nations of men." Heraldic achievements of the United States displayed very artistically in blue and white give us a good idea of the state of the potter's art during the latter part of the last century.

Members of the political ring hereabout should cut their viands from plates with such extracts on them from the Constitution, that they might be reminded at every meal that they have no constitutional right to interfere with the "Mormon" or any other religion.

Entertainments.—Mr. George Rowley, of American Fork, a blind organist, is in the city, giving entertainments at the school-houses of the various wards. Besides instrumental and vocal musical exercises, he exhibits exterior and interior views of the Centennial Exhibition, also views of various parts of the world, by means of a selenicon. He appears at the 14th Ward Assembly Rooms to-night, at the 15th Ward on Friday evening, and at the 20th Ward school-house on Saturday evening.

A feature among the views is a series showing the stages of progress of the work on the St. George Temple, and of its present advanced condition.

P. E. Connor vs. Benjamin Hampton; by consent, passed for the present.

John Tienman vs. Nicholas Treweek; by consent to be taken up November 22nd, 1876.

Brigham Young vs. J. E. Tyler; same order as in previous cases.

George P. Livenford vs. Wm. J. Hall; appearing as attorney for the plaintiff and no one appearing for the defendant, the case was submitted.

"We, the jury, find for the plaintiff, and assess his damages at five hundred and seventy-three dollars and thirty cents."

The Universal Topic.—The universal topic on the streets to-day has been the presidential election. Groups of men have been gathered on the sidewalks discussing the situation, according to the latest news. The Democrats have been exceedingly jubilant, being confident that Tilden's chances for the White House are away ahead of his opponent's, and although the Republicans hereabout have not altogether lost hope, they generally concede that appearances are very much against the ultimate success of the candidate of their party. However, although the matter can be pretty correctly prognosticated beforehand, in a political contest where the parties are so apparently evenly divided absolute certainty can not well be attained until the matter has been decided by the votes of the electoral college.

It will be seen by a dispatch to-day that the Republicans claim 131 for Hayes to 174 for Tilden, but it is admitted in the same that the Republicans don't claim North Carolina, and that being included in making up Hayes' total, and having 10 electors, this would probably reduce his quota to 171 and increase that of Tilden to 181. The Republicans appear to consider Wisconsin, which has 10 electoral votes, and Florida, 4 votes, doubtful; and as States considered doubtful by the Republicans have been going almost invariably for Tilden, should that rule hold good in these instances, Tilden's total would run up to 198, giving him a majority of 27.

Another dispatch has just come to hand, which states, in effect, that unless Florida, Nebraska, Nevada, Oregon, Louisiana and South Carolina, the States not heard from, go republican, Tilden will be elected for certain, as it will take the whole of these to give Hayes a majority, while any one of them going democratic will secure Tilden's election. If this be the case, the strong presumption is in favor of the democratic candidate. Besides, it is asserted that private dispatches state that Florida has gone for Tilden, which, if true, makes his election almost a matter of certainty.

City Council.—The Council met last evening, Mayor Little presiding.

Petition of Barratt Bros., for an auctioneer's license, granted.

Petition of David Love, for the privilege of running a skating rink on the Old Adobe Yard during the approaching winter; granted, under the direction of the Marshal.

The Marshal presented his report of expenditures for the month of October, amounting to \$200.57; report received and amount allowed appropriated.

The following bills were also allowed and appropriated.—W. Hyde, for boarding city prisoners, in October, 1341 meals at 15 cents; \$197.10; Treasurer, for one month's salary, \$300; Captain of Police and City Marshal, salary for October, \$155; City Hall janitor, for one month's salary, \$52; street supervisor, for month's salary, \$150; W. E. Hyde, salary for lighting lamps and guarding waterworks tanks, \$80; C. M. Dunsford for work in connection with fire department, in October, \$70; R. Simpson, engineer of fire department and janitor of Fireman's Hall, salary, \$63; expenditure in the fire department \$250.

The sum of \$500 was appropriated to pay interest for October on borrowed money.

The sum of \$1,000 was appropriated, for public improvements, to be held subject to the order of the Supervisor.

Council adjourned till next Tuesday evening at 7 o'clock.

No further developments of the small-pox. There are now only fifteen cases in town, all told. Remember this, and don't be scared nor influenced by exaggerated rumors.

Everything extremely quiet at the polls in this city to-day. Votes rolling up a goodly figure for Cannon. No excitement, no vulgarism, no vulgarity, everybody who voted doing so freely and without fear or constraint. Just as it should be.
