POLITICAL CONFERENCE.

Lack of Interest in Forthcoming Election—Present Administration May be Renominated.

PRIMARIES HELD NEXT WEEK.

District Court Cases—Erick Edvalson Laid to Rest—Board of Education—Wedding Bells.

Another city election will be upon us within the next month, but up to the present time very little has been said about it. The question has been asked during the past week if the political parties had agreed on letting the present city officials hold over for another term without holding an election.

There is but little activity in the political arena at present, and unless something unusual happens the coming November will witness one of the quietest elections ever held in this city. It is generally conceded that the present occupants of the various city positions feel sure of re-election. The question now is, who are the Democrats going to place on their tickets? H. W. Gilliam, of the Fourth ward, seems to be the favorite for mayor, and G. H. Johnson, of the Second ward, is understood to be chosen for city clerk. No one seems to be in the running for the other positions. The Democrats are feeling jubilant over the commencement of the new daily Democratic paper in Ogden, with the editorial columns under the able pen of ex-Senator F. J. Cannon, and believe that through the columns of their press to bring life to the Democratic ranks who have gone down to defeat for several years. Primaries will be held during the next week, and the conventions the week following, leaving only a very short time for electioneering.

JUDGMENT FOR SIX CENTS.

In the district court before Judge Rapp the case of Marion Beus against Richey, suit brought to recover \$50 damages and a permanent injunction, was heard. The court after hearing a number of witnesses on both sides, granted the injunction and a verdict of damages in the sum of six cents.

In the case of Ogden Milling & Elevator Company against Moron Sken, the motion of the Plain City irrigation company to intervene as defendants, was denied.

In the case of Henderson & Van Allen, the court heard argument on a motion to reduce the charges of securing a deposition in New York from \$25 to \$11 and granted the same.

In the case of Max Davidson vs. E. A. Meney, ordering that the bill of exceptions with the judgment roll in the action be vacated and set aside, on appeal, the supreme court of this state and the same will be transmitted to the second district court so that the errors in the same may be corrected.

The testimony in the case was heard by the district court on the birthday of this year, and it being legal holiday, no testimony should have been taken, and the bill of exceptions on appeal will have to be amended to read that another day when the state supreme court will hear it.

ERICK EDVALSON LAID TO REST.

Erick Edvalson, a well known resident of Ogden, who died last Tuesday, Oct. 6, aged 31 years, 10 months and 13 days, was laid to rest yesterday in the Ogden city cemetery. The funeral services were held at 2 o'clock at the home of the deceased, where the Rev. Mr. E. A. Meney presiding. The ward choir furnished the music. The speakers were Elders Carl R. Erickson, E. A. Olsen, John Anderson, John Purnell, Ole Olsen and H. W. Gilliam, who spoke many words of comfort to the bereaved wife who is left with three children. The funeral was held on the 10th, showing the powers were laid on the 11th, and the body was laid to rest in the cemetery. The deceased filled a mission to Sweden a time ago. LEAVE FOR FOREIGN MISSIONS.

Elder Joseph Mair leaves next Monday for Germany to fill a mission. Elder Mair is a zealous worker and is sure to achieve desirable results.

A farewell party was given in the tabernacle for him Thursday evening, at which a pleasing program was rendered. Elder Mair's wife will take up her residence with friends in Ogden during his absence.

The directors of the "Hatchery Bros." Banking company held their regular quarterly meeting Thursday, and declared the usual dividend of 2 per cent per quarter.

TYPHOID CASES.

A son of ex-Senator Aquila Nebeker is lying quiet at his typhoid fever. He is now in the hospital at Provo, and is reported to be dangerously ill with typhoid fever.

There are a considerable number of cases of typhoid fever in Provo, and several in Logan, but the disease is not so widespread as has been rumored. A dozen would sum up all the cases in Logan.

POLITICAL APATHY.

Anything like the apathy shown in political circles in Logan at present has never been known in this city. Chairman Roberts of the Republican party and Chairman Wilson of the Democratic party, are each waiting for the other to move. It is claimed that neither party is willing to be nominated and their names certified to by the 15th, so there are but a very few days left in which to call primaries and a city convention. Candidates are far from numerous, and many citizens, who have been asked to accept nominations, have declined to run.

CITY COUNCIL SESSION.

The Logan city council held its regular semi-monthly session Wednesday evening. President Johnson occupied the chair. A large amount of routine business was transacted, such as granting liquor licenses, etc.

Paving district No. 2 was created, comprising the two sidewalks leading one block west from First West street on Center.

Watermain extension No. 12 was created, leading from the Second ward watermain to the depot. The old wooden pipe in this district will be replaced with iron pipe.

Nov. was set as the date when property will be heard against the improvements.

All heads of department filed their quarterly reports.

Fire Chief Robbins reported four fires and \$50 damage in that period. Sexton Peterson reported 30 deaths, 8 males and 22 females. Justice Anderson reported \$91 collected in fines.

Marshal Crockett reported 40 arrests. Poundkeeper Guelin reported 38 animals impounded, and \$31 collected.

Paving district No. 2 was created, comprising the two sidewalks leading one block west from First West street on Center.

A. L. Cole and Mr. Lee petitioned the council to lay down water pipes to the residence of Mr. Lee.

W. R. Andrews asked the council to allow him to sprinkle the six extra blocks outside of the sprinkling district, to balance the balance of the season. Not granted.

The city recorder was instructed to notify the Democratic and Republican chairmen to furnish names of candidates for the coming election.

The committee on paving recommended that street crossings be laid in cement instead of stone. Adopted.

The cemetery was discontinued after Oct. 15.

Sexton Peterson recommended that steps be taken to correct defective titles to cemetery lots.

After allowing many bills, council adjourned for two weeks.

P. J. Moran was filed suit in the First district court against J. F. Bowman and Fred Madden, contractors, for \$1,389.25 and interest alleged to be due on a building contract.
