Metcalf and declaring that his report to the president on the Japanese school question as being "utterly unworthy of credence in any particular," and containing "numerous misstatements and misrepresentations, ob-

viously one-sided and grossly exagger-JUDAISM AND ated," were adopted at a mass meeting held this afternoon at Walton's pavillon under the auspices of the Japa-

nese and Korean Exclusion league. About 2,500 people were in attendance. O. A. Tvietmoe, president of the league, and secretary of the state building trades council, acted as chairman. Among the speakers who addressed the Among the speakers who addressed the meeting were Mayor Schmitz, Police Commissioner W. R. Hagerty, who is also president of the San Francisco La-bor council; P. H. McCarthy, president of the building trades council; Walter MacArthur, editor of the Coast Sea-man's Journal, and other prominent inbor leaders. Mayor Schmitz said that he was
