About 40 tons of hay was stored in the shed, all of which was consumed in a very short time, with a loss of about \$800, with no insurance. A large crowd soon gathered with buckets in hand and made heroic efforts to save other buildings, some of which were torn down and carried away to save from burning. The Central Lumber yard was threatened, not being more than 25 feet between the fire and its buildings, but fortunately the wind blew the intense heat away from the lumber yard. The Provo fire department was sent for and extinguished the smoldering mass of timber and hay to prevent any further spread in case a wind should come up.
