OFFICIALS VISIT STATE SCHOOL

Industrial Institution Found in

All Departments.

The morning was spent in visiting the various departments of the school, including the girls' cottage. After a luncheon the printing, carpenter, blacksmith, shoe shop and tailoring departments were visited. In the gymnasium the visitors had an opportunity of seeing the young people give a splendid exhibition.

FALLS AMONG THIEVES.

Story of a Highhanded Robbery Being Investigated by Police.

Ogden, Dec. 23.—The police are still investigating the story of Fred Goff, an aged man, who claims that he was robbed and held prisoner in a room in the rear of the Apex saloon for two days. The old man's straightforward manner in telling of the crime has aroused considerable interest among the officers and a thorough investigation is being conducted.

According to Goff's story he had been working with a steam shovel gang west

of Ogden for a number of months and had saved up about \$100. He started for Chicago to visit his daughter for Christmas and when he arrived at Ogden he went to the Apex saloon for a drink of beer. After taking three drinks he says that he remembers nothing and when he came to he was in a rear room and held a prisoner, all his money and watch gone.

Goff's statement to the police that he had \$60 in gold besides a gold watch and \$20 which he drew from an Ogden bank have been verified by the police. From Walker Brothers' bank in Salt Lake City it was verified that Goff had received \$50 in gold. All other statements made by Goff have thus far been proven. The proprietors of the Apex saloon, B. F. McGuire & Co., strongly deny any connection with the robbery. As there are several saloons on lower twenty-fifth street, which are known to have had a hand in relieving men of their money during the days of the building of the cut-off, it is very probable that some very decided action will be taken by the police committee of the city council and later by the council when the present case is thoroughly sifted.

DISTRICT COURT BUSINESS.

R. S. Brooks and B. B. Brooks comprising the firm of R. S. Brooks & Son, live stock commission merchants, have brought suit in the district court against the Western Union Telegraph company to recover \$500 damages. The plaintiffs allege that by reason of the failure of the defendant company to deliver a certain telegram at Preston, Nebraska, they lost the commission on a certain sale of cattle.

Suit for a divorce was filed in the district court yesterday afternoon by Mary V. Baer against Andrew S. Baer upon the grounds of non-support. The couple were married in Ogden, Aug. 22, 1902.

In the probate division of the district court Nellie Cook has filed a petition for letters of guardianship in the matter of the estate of Annie Cook, a mil-

nor. The estate consists of an interest in real estate valued at \$550. George Adamson and John McCune, charged with robbery, are on trial before Judge Howell. The case will probably occupy the attention of the court for the entire day.

Attend Convention—During the past two days there has been an unusually heavy exodus of school teachers of the city and county schools to the state teachers' convention in Salt Lake City. A number of the educators from this county are on program to deliver papers upon various topics.

Buried in New York—The body of Mrs. Amanda Miller, wife of Adolph Miller of Salt Lake City, who died at the Utah Hot Springs Monday evening of Bright's disease, was shipped by Larkin & Sons to Livingston, New York, yesterday afternoon where burial will take place.

Died in Infirmary—Louis Mollery, an aged inmate of the county infirmary, died at that institution Monday evening of tuberculosis, from which he had been suffering for many months. The body is being prepared for burial by Larkin & Sons.

Police Court—In the police court before Judge Murphy, Sam Headrickson, who claims his home in Salt Lake City, was given 30 days upon the charge of defrauding a roominghouse keeper, named Fred Baker, out of his room rent.

CITY COUNCIL SESSION.

Resignation of Councilman Van Wageningen—Waterworks Bonds Redeemed. Special Correspondence.

Provo, Dec. 23.—At the meeting of the city council the resignation of J. F. Van Wageningen, councilman from the Fifth ward, who has removed to Los Angeles, was presented and accepted. A communication from Chairman Cliff of the Fifth ward Republican committee, recommending the appointment of George S. Taylor to succeed Mr. Van Wageningen was also presented. Action was deferred for one week.

A communication was received from the D. & R. G. Ry. company accepting the franchise for a union depot.

The mayor, council and former Mayor Pease were appointed a committee to entertain the Municipal league of Utah, which will meet here on the 29th and 30th.

The waterworks bonds committee was authorized to purchase for \$1,000 outstanding waterworks bonds.

VICTIM OF APPENDICITIS.
James Gray, one of Provo's most prominent and highly respected citizens, died this morning in the Provo general hospital of appendicitis. He was survived by his wife and children and a wide circle of friends. He was born in New Brunswick, Canada, Feb. 23, 1848, and came to Utah with his father's family in 1864. Since which time he has resided in Provo, being intimately identified with the growth and development of the town. He was for several terms a member of the city council, and filled other positions of trust.

ELWELL FINED FOR ASSAULT.

Suit Against Trustees of Coveville Irrigation District.

Logan, Dec. 22.—The State of Utah, by M. A. Breeden, attorney-at-law, ex rel. George Cornish is plaintiff to a suit filed in the district court against Joseph S. Allen, Fred Titensor and David Allen, defendants. The suit is brought to oust the above named defendants as trustees of the Coveville Irrigation district, alleging that no such irrigation district has ever had any legal existence. The complaint sets forth that the above persons have, since Dec. 2, 1902, pretended to exercise corporate powers in controlling the waters that flow within the boundaries of the Coveville precinct. Nebeker, Hart & Nebeker are attorneys for plaintiff.

Alfred Smurthwaite has brought suit against the Logan Furniture company and Isaac Stewart, to restrain defendants from disposing of any moneys that have been received by converting the property of the company into cash until plaintiff be adjudged a creditor of the company.

Isaac Elwell, Jr., has been sentenced by Justice Wm. Bringham to 30 days in jail and \$50 fine, which means 30 days for beating John W. Att, the man who afterwards shot Junius Nielsen.

KILLED IN A SNOWSLIDE.

Edward Petersen Meets Sudden Death At Sunnyside.

Murray, Dec. 22.—Edward Petersen, a youth of 18, raised in Murray and well known here, was killed in a snowslide on Sunday at Sunnyside in Carbon county. He was an employee of the Utah Fuel company. Last Sunday he and a companion named Whalen started from No. 3 mine to go to the town, and both were caught in a snowslide. Whalen escaped, but young Petersen was carried against a tree and killed instantly, his skull being crushed. His body was recovered and it will be brought to Murray for interment.
