CONGRESSIONAL

SENATE.

Discussion on the Funding Bill—The Revels Case—Various Bills Introduced, One to Fix Junction of U. P. and C. P. R. R., and one to Establish a system of National Education.

A bill to secure all persons the equal protection of the laws in respect to life and property was considered during the morning hour, but without action. The question of the admission of Revels was postponed to accommodate Fenton and Patterson, who desired to make speeches on the funding bill on account of their necessary absence after to-day. Fenton desired an amendment to the present bill as to authorizing a single bond at four and a half per cent, in a sum of a thousand or twelve hundred millions, not taxable by Federal, State or local authorities; payable in not less than forty or more than fifty years, at the same time relieving the five-twenty and ten-forty bonds, and affecting a gradual contraction by gradual absorption of greenbacks in new securities, which would result in the resumption of specie payment. He favored the funding bill, but thought it would be greatly improved by this amendment, not only because it would involve a reduction of interest but would end in a claim, which threatens to violate public faith and impair public credit.

Patterson spoke on financial topics and in favor of funding the debt. The Revels case was then taken up, the question being on the motion of Stockton to refer the credentials of Revels to the judiciary committee. A discussion ensued which was participated in by Saulsbury, Williams, Howard and Cameron, but the House adjourned without action on the case.

Williams, from the committee on commerce, reported a substitute for the bill incorporating the Missouri, Kansas and Texas Railroad company.

Howard reported with amendments, a bill to fix the place of junction for the Union and Central Pacific railroads.

Howard introduced a bill to divide the State of Texas and establish the Territories, Jefferson and Matagorda; referred.

Other bills were introduced, among them was one, by Starkweather, to encourage the building of first-class iron steamships to aid in restoring the commerce of the country, and for carrying the United States mails by the hour; one to establish a system of national education.

Jencks, from the committee on re-trenchment, reported a bill to establish a department of justice; recommended. Adjourned.

WASHINGTON.

Mississippi Bill Signed—Forewarned of assassination—Heavy judgment against the United States—Opposition to the Postal Telegraph System—Another Cadet-selling Case under investigation.

WASHINGTON.—The President has signed the Mississippi bill. Prominent friends of Cuba state that an ominous vote has been received by voting Consul Gen. Hall recently warning him that he is in danger of assassination. It could not, it is said, have originated from a Cuban source as none but Spaniards have been engaged in the assaults on citizens of the United States.

The court of claims has rendered judgment in the case of Bernheimer Bros., of New York, for a hundred and eighty-five thousand dollars against the U. S. for the proceeds of cotton taken at Savannah. It is the largest judgment that has ever been awarded by that court.

WASHINGTON, D. C., 24.—President Orton, of the Western Union Telegraph Company, made argument before the Senate postal committee, to-day, in opposition to the Hubbard bill. He gave statistics to show that the telegraphic rates of this country are less per mile than those of Europe, and that the telegraph is more used here in proportion to the population than in Europe. He opposed the bill because it would not protect the public against monopoly, since it would be easy for the Western Union Telegraph Company to take possession of the organization. He said the receipts of that company last year were six and a half millions; the expenses were four and a half millions. The same amount of business would, under the Hubbard bill, produce less than two millions, one million short of what his company paid for salaries. An increase of fifty per cent. in the volume of business would still leave it deficit more than a million. He concluded by submitting a proposition that the company be released from all taxes, which would allow them to make an average reduction of one-seventh of the present rates of tariff, and give them a free right of way along the railroads, as proposed in Hubbard's bill, which would allow a reduction of another seventh; then let Congress provide for a commission to appraise the cash value of the property and franchises of the company, on which sum they shall be entitled to a percentage per annum; and the company will surrender to the Post-office Department the right to fix the tariffs.

The committee on military affairs were engaged to-day in investigating the case of Representative Golladay, who is charged with selling a cadetship.

MASSACHUSETTS.

Boston.—John Ward and wife were suffocated last night by the fumes from a charcoal fire in their bed-room.

OHIO.

Sudden Death.

CINCINNATI.—John F. Clareman, one of the proprietors of *Volk's Friend*, and for sixteen years connected with that paper, died suddenly last night, aged 62. He was a prominent and excellent German citizen.

MINNESOTA.

Woman Suffrage probable in Minnesota. The Minnesota Senate yesterday, by a vote of 12 to 9, passed the House bill to provide for the submission of an amendment to the Constitution, allowing women the suffrage. The bill provides for the taking in separate boxes the votes of women. The Governor will probably sign the bill.

NEW YORK.

Fatal Mining Accident.—A Theatrical Fizzle.—Men of War recalled.—Banquet to the officers of the "Monarch."—A Bank Messenger robbed.—Reported seizure of invoice.

PORT HENRY, N. Y.—A portion of the Roofed Bed mines fell in yesterday, crushing two miners under three hundred tons of ore.

NEW YORK.—The messenger of the State Bank of New Brunswick, N. J., was robbed while in the Currency Department of the Sub-Treasury, to-day, of seven thousand dollars in bonds and a thousand dollars in currency.

The Tammany Theatre collapsed yesterday; the managers are out of town, the company unpaid and the doors closed. This makes the third *fiasco* in the amusement business this week.

Orders have been received from the minister of marine, requiring the return to the peninsula of the Spanish men-of-war now here. They are to return in February, as the Delameter gunboats will render the presence of those large vessels unnecessary in Cuban waters.

It is said the officers of the Brooklyn navy yard have invited Captain Commerell and the officers of the *Monarch* to a grand ball and supper, to be given within the precincts of the Brooklyn navy yard; and that they have accepted it.

The gunboat *Yantic* left the navy yard yesterday to take in her powder at the battery and to go from there to the West Indies, on an expedition to take soundings between the different islands for the purpose of laying a cable.

The committee on reception of Seward are to meet that gentleman at the Astor House this evening, to learn his wishes as to the time when the proposed banquet shall take place.

It is stated that the Erie company has offered six hundred thousand dollars for the ground on which the Protestant Episcopal Theological Seminary now stands, on 6th Avenue, with a view to build a monster railroad depot on the property; it is also stated that Erie cars are intended to cross the river from Jersey City by means of a gigantic tunnel running under the river.

ILLINOIS.

An Editor horse-whipped by women.

CHICAGO.—W. F. Story, editor in chief and one of the proprietors of the *Chicago Times* was last evening horse-whipped by Lydia Thompson and Paulina Markham, of the Lydia Thompson burlesque troupe, performing at Crosby's Opera House for a week or two past. The affair occurred in front of Story's residence, on Washington Avenue, where his assailants were waiting for him when he came home to dinner. Henderson, manager of the troupe, was with the belligerent ladies at the time. The cause of the attack was the recent severe criticisms in the *Times* on the performance of the company, coupled with a gross personal attack on the Misses Thompson and Markham. They with Henderson were arrested and taken to the armory, but were admitted to bail to answer the charge of disorderly conduct. It is reported that Story has since requested the charge to be changed to one of assault with a deadly weapon with intent to do bodily injury, he claiming that Henderson drew a pistol on him.

TEXAS.

A Million Dollar Fire.

GALVESTON.—A fire last night destroyed an entire block on the north side of the Strand, between Front and 22nd St. and the opposite block on the south side of the Strand. Many of the houses were of small value; but they were filled with goods; the loss is estimated at a million dollars.

COLORADO.

Dubois Caught and Killed.

DENVER.—Dubois, who killed Kinney, near Burlington, yesterday, was overtaken by a party of citizens early this morning in the mountains, and was immediately shot, being pierced by thirty bullets.

FOREIGN NEWS.

WEST INDIES.

Reforms in Cuba—Eighteen Persons Executed.

HAVANA.—The Captain General has issued an important decree which grants liberty to over two thousand negroes, prisoners of war, who have been hired out by the government with the understanding that they are to become slaves after a certain date. The decree declares that every one willing to work can take care of himself, while the laws will protect all classes. The measure is warmly applauded by the liberal and progressive party. The Captain General intends to issue a de-

cre abolishing private trial by special courts as hitherto enjoyed by persons in the army, navy and church and foreigners. This will abolish tribunals for foreigners and others and will strike at the root of a partial and unjust administration of the laws.

The *Diario* publishes a document revealing the existence of a Cuban Junta in Santiago, which has for a long time assisted the insurgents with information and materials of war. The members of the Junta, eighteen in number, have been arrested, and the charges against them having been proved they have all been executed.

CANADA.

Fatal Still Explosion.

LONDON, CANADA.—A still in the oil refinery of Englanard & Co., exploded, fatally injuring one man and severely burning another; damage about ten thousand.

GREAT BRITAIN.

Bright's health—Precarious Violence at Elections.

LONDON.—The condition of Mr. Bright's health creates deep anxiety. The elections at Waterford and Nottingham were attended with scenes of violent excitement; in both places disturbances occurred and persons were roughly treated.
