PILGRIMAGE OF THE UTAH PIONEERS SIXTY YEARS AGO TODAY.

MONDAY, JULY 19, 1847.

Elders Orson Pratt and John Brown started from the advance camp soon after sunrise to examine the road and country ahead. "We continued along the road which we explored the day before," writes Elder Pratt, "and ascertained that the road left Canyon Creek near the place where we stopped the day before, and ran along in a ravine to the west. We ascended this ravine gradually for four miles, when we came to the dividing ridge, Here we fastened our horses, and ascended on foot a mountain on the right for several hundred feet. Both from the ridge, where the road crosses, and from the mountain peak, we could see over a great extent of the country. On the southwest we could see over a great extent of the country.
