HORRID BEDFELLOWS

TARANTULAS CRAWL ALL OVER A SLEEPING TRAVELER.

A Third Camper Who Awoke One Morning to Find a Tarantula Creeping Across His Anatomy. While Another Made a Bed of the Man's Upright Hair.

tarantula looking into mine, with its hairy body on my face, not two inches away.

"Choosing that death or at least pain, I immediately dropped. The spider had the satisfaction of feeling the sprawling spider crawl over that eye to my forehead and into my hair, where it prepared a venomously injected dinner, and then a short while after, crawled out again, slightly fatigued.

You may think you can imagine my feelings, but you cannot. For a full hour, I should judge, I endured all the suspense and torment that comes to most men in a lifetime, and allowed another spider to crawl over my face, and then, occurring at what time I could not guess, black tangs shot into my flesh.

"But thank God, that did not happen, or I should probably not now be alive. After that, as it seemed, Dr. Heath arose, and after a hasty breakfast, I was allowed to go to bed again, and I was permitted to tell the particulars of my plight, and in my turn, which had been standing on end for I don't know how long, as I recovered and at once killed one of the insects as became necessary, fully trust in God. I was then allowed to go to sleep again, and I slept soundly, and when I awoke, I found twelve others that had undoubtedly sought my quarters for warmth.
