OGDEN NEWS. - - JAN, 5, 1900. OGDEN. TWO SUITS FOR DIVORCE. Drunkenness, Cruelty and Desertion Set Up as Causes for Separation.

#### Mrs. Melissa J. Stoker and Mrs. Emanuealause are the Complainants-Horse and Cutter Stolen.

A suit was filed yesterday by lielissa J. Stoker against her husband, Charles A. Stoker, and the Ogden State bank. The action is one for divorce and sets forth that the plaintiff and defendant were married in S alt Lake City on September 26, 1895, and that they have two children, a boy and a girl, as result of said marriage. The plaintiff alleges that for the past three years the de-fendant Stoker has been a habitual drunkard, and has treated plaintiff in a cruel and inhuman manner; using vile and profane epithets in the presence of the children. The last of his crue, rampages occurred on January 3, 1900, when he came home in an intoxicated condition and ejected her from their home, and then nailed the doors and windows up so that plaintiff cannot get in the house to obtain clothing for herself or children. For over a year, plaintiff states, she has been compelled to rely upon relatives and friends for her support, defendant having refused to provide for her. He has, she says, \$150 worth of personal property and a deposit of \$650 in the Ogden State bank, and therefore the said bank is made a party to the action. The defendant prays that the bonds of matrimony be dissolved, that the custody of the two minor children be granted to plaintiff, that the defendant be enjoined from selling any of the personal property or from withdrawing any of the \$650 from the bank and that the said bank be enoined from delivering to defendant Stoker any of his deposit now in their possession, and that the court grant such alimony and other relief as may

seem just. Another divorce suit was filed by Stewart Emanuealaus against John M. Emanuealaus, on the grounds of desertion and failure to provide, the defendant having deserted plaintiff since 1889. She therefore asks that a decree of divorce be granted and that the custody of their 12-years old boy be given to plaintiff.

#### HORSE AND CUTTER STOLEN.

Thomas Hunt and Ben Douglas were arrested on complaint of W. W. Elmer, charging them with stealing his horse and cutter on the night of December Sist and of having broken the cutter se so cruelly as to have ruined him for future driving. Douglas alleges that he had nothing to do with the taking of the horse and cutter, but that Hunt came and got him and asked him to come and take a sleigh ride, which he did not knowing that Hunt had stolen the outfit. The young men are endeavoring to compromise and pay for the breaking of the cutter and injury to horse and cost of suit and have the case dismissed, but whether Mr. Elmer is willing to settle the matter in this way is doubtful as this is the second time he has had his outfit stolen and misused.


