TERRE HAUTE, Ind., 23.—Mr. Blaine

left Evansville at 8:30 this morning,

having before him a long day's ride to

manner. At Terre Haute there was a

great demonstration. As the train

Mr. Blaine with wild cheering. He was

escorted by a reception committee,

headed by the Mayor, to a carriage and

driven in the procession through the

crowded city for about an hour. Upon

reaching the depot he made the fol-

lowing speech: "The Southern

That Broken Bank.

WASHINGTON, 23.—The firm had at

last reached a point, however, when its

remaining assets proved to be unavail-

able for immediate use, and the bank

can be realized upon only by good

management and waiting for suitable

opportunities. The firm has no in-

vest in the Washington and Ohio rail-

road, although Mr. Campbell individ-
