He quoted the words of the Chaplain of the colonists that, 'God hath revealed his whole will to the colonies and recognition of the great law of human progress.' 'Miles Standish, a soldier, sent to England to raise funds, brought back 150 pounds, which he raked at fifty per cent. So much,' said the speaker, 'was the seed of the great expedition (laughter). That company of men, taking little beyond their own provisions, and the country are become famous beyond the lot of men, showing that the true greatness is that
