



OLSEN.—The little town of Layton, Ari., was startled on the morning of June 26, by the announcing of the sudden death from malar-ial fever, of Rosa Olsen, daughter of Chas. and Evelulsin Olsen; born November 26, 1866, died June 26, 1884.
