

# WIFE IS IN RUSSIA.

Mr. Andrew Backlund Refuses to Leave the Country for Russia.

SO HER HUSBAND SEEKS A DIVORCE.

Head of the Russian Case-Setting of Cases Short Office. Miscellaneous Court Orders.

John Backlund filed a suit for divorce in the Third District court today against his wife, Anna Backlund. The parties were married in Finland, Texas, January, 1894. In 1895, for the purpose of bettering his condition, plaintiff says he came to America and shortly afterwards settled in Utah. Since his arrival here, he says, he has at all times provided for his wife and means for her support and has also prepared a good home for her in Utah. He further says that he has repeatedly sent for her to come, but she persistently refused to do so, notwithstanding plaintiff pays for her maintenance and sends her money from time to time. It is also stated in the complaint that Mr. Backlund returned home in 1895 for the sole purpose of procuring his wife to join him, but it was to no purpose, she refused to come and he was compelled to return alone. Trying at his own and having abandoned all hope of reconciliation, Mr. Backlund now prays for a dissolution of the matrimonial bond, and such other relief as to the court may seem just and equitable.
