The will astonished even his most intimate friends, for it showed that he had amassed a fortune valued at one-quarter to half a million of dol-

The romantic interest in the will arises from the fact that a bequest is made to Prof. Dubois' daughter. Not even the old schoolmaster's most intimate friends, and his confidants were few, knew he had been married, and the testator, in naming the daughter, only her given name because he

did not know to whom she had been married. Investigation shows that the married. Investigation shows that the professor separated from his wife near-ly 50 years ago. She went away, taking their little girl, and neither the husband nor his relatives ever heard from them again. They are supposed to be still alive and in this country, but where no one knows. The professor to the profe sor's relatives refuse to give any in-formation regarding the affair long buried in the past, but it is said the wife was a member of a well-known



their official capacities, have wrongfultheir official capacities, have wrongfully and without authority of law, issued the bonds of the state to the amount of \$93,000, under the act of the legislature approved March 16, 1903, and will dispose of same unless restrained by an order of the less restrained by an order of the court. That afflant believes that said act was void and contravenes the constitution of the state of Idaho.

constitution of the state of Idaho.

That said act attempts to increase the expenditures and appropriations which said session of the legislature attempted to authorize for the years 1903 and 1904, contrary to section 11, article 7, of the constitution. That said attempts to create debts, which added to the existing debts of the state, exceed one and one-half per cent of the assessed valuation of the property in the state, contrary to secproperty in the state, contrary to section 1, article 8, of the constitution.

It provides, or attempts to provide by taxation, money for private pur-poses; money to be paid out of the state treasury in bounties to the producers of sugar in Idaho from beets grown in Idaho, to subsidize and assist the private enterprise of manufacturing sugar in the state of Idaho, contrary to section 2, article 8 of the constitution.

It provides, or attempts to provide money raised by general taxation for the construction of a local bridge and a local road, both of which were at-tempted to be authorized by acts ap-proved Feb. 27, 1903, and March 11, 1903, contrary to section 19, article 3, of the constitution.

That the total assessed valuation of property in Idaho for the year 1903, as equalized by the state board, amounts to the sum of \$65,961,583.09. That the total indebtedness of the That the total indebtedness of the state at the time of convening of the seventh session of the legislature, was \$752,619.54. That the specific appropriations, the legislature assumed the authority to pledge the faith and credit of the state for the payment of credit of the state for the payment of bounties upon sugar produced in the state during 1903 and 1904 in some uncertain and unascertained amount, under the act, provided March 11, 1903.
