We arrived here last night and opened the Telegraph Office to-day, Great rejoicing in consequence. At eleven o'clock Captain Scoffield Holgate serenaded the office with his fine band, and to-night we are enjoying ourselves at a splendid party gotten up in honor of the occasion by acting Bishop Ashworth, H. A. Skiuner and others in the Beaver Social Hall, a large brick building just finished. There has been no snow here this winter and the roads are good.

mains here as operator.

We received a report to-day that Captain Andrus, of St. George, followed a party of thirteen Indians, supposed to be Navajoes, who had stolen some stock from Pine Valley, Washington County, and were going South. Overtook them south of the Virgin; killed eleven Indians and recaptured the stock. Our party is growing smaller every day, but all are well.

To-day the people are rejoicing over the quick reception of despatches from Great Salt Lake City. Many of the citizens moved here in 1851, to whom the workings of the Telegraph seem almost a miracle. To-night we are to have a grand ball, at which both brass and orchestral bands will be in attendance. Snow is falling fast this morning, for about the first time this winter, and prospects are favorable for good sleighing. The Indian fight which we reported from Bea-

ver by Telegraph is confirmed. William B. Dougall of Springville remains here as operator, and is much pleased with his

FROM SPANISH FORK .- We were favored with a visit on Thursday from Elder G. W. Wilkin and Elder James Robertson from Spanish Fork, who bring a good report from that thriving place. More water is being taken out from Spanish Fork river for irrigation purposes, and the design is to enlarge the city considerably in consequence. Bishop A. K. Thurber is again to fill the office of Bishop there, Bro. Wilkin having filled the position since Bishop Thurber started on his mission to Europe. The citizens gave their choir a fine party lately, at which all present enjoyed themselves in the best style. The brethren report no snow, comparatively in Utah county.

THE CITY HALL CLOCK. - This fine addition to the useful and ornamental of the City is now showing time to our citizens, with its four dials facing the cardinal points. The clock was put up by Mr. W. As the dials are transparent, a suggestion to have it illuminated at night, may not be out of place. This would add still more to its value as a public benefit. The following dimensions, courteously furnished us, will give a better idea of its size. than a lengthy description:-Weight of clock, 400 lbs.; pendulum weight and compensation, 60 lbs.; diameter of dial, three feet; length of pendulum rod, fourteen feet; weight of bell and mounting 875 lbs.
