

TAFT CONCLUDES HIS TOUR OF OHIO

Issues a Statement Saying He Found Everything in Satisfactory Condition.

CERTAIN OF A GOOD MAJORITY

Delighted to Look Into Eyes of Audience of Such Intellect, and Therefore of Such Republicanism.

Wheeling, W. Va., Oct. 14.—Judge Taft today concluded his three days' campaign in Ohio. What he thinks of the situation is set forth in the following statement which he issued tonight.

TAFT'S STATEMENT.

"I have now spent three days in the state of Ohio, much of the time in industrial and labor centers among men who, it was reported, were disaffected and opposed to the Republican party and its candidates. Wherever I appeared I was cordially received, and only an occasional interruption indicated that misrepresentation of the attitude of the party and the candidates had made a casual impression. It is my opinion that the attitude of labor toward the Republican party has been misrepresented as freely as that of the party candidates toward labor, and I find no reason for the belief that labor will divide other than on the lines that have heretofore divided it. In my opinion the normal Republican labor vote will be cast as heretofore.

"In the agricultural regions it is quite apparent that the farmers are opposed to a change that will imperil their present prosperity.

"The situation in Ohio is entirely satisfactory, and no one has any reasonable doubt but that the Republican majority will be a substantial one. I certainly have no doubt on the subject myself."

TALK TO FARMERS.

At Cadiz the candidate made his talk to farmers in the center of the wool-growing district. It was just dusk when Judge Taft left his home state and pulled across the Ohio river to West Virginia.

"It is impossible for me to make myself heard. BRYAN TOURING HIS HOME STATE

Expresses Himself as Pleased With Reception Given Him By People of Nebraska.

22 SPEECHES YESTERDAY.

Would Feel Mighty Lonesome in Washington Were Senate and House Against Him.

Hebron, Neb., Oct. 14.—The second day's tour of Nebraska by William J. Bryan was brought to a close at this place tonight. Twenty-two speeches were made during the day by the Democratic candidate, varying in duration from ten minutes to one hour.

It was by far the most enthusiastic day for Mr. Bryan during the trip, and the crowds which greeted him at the various stations were composed largely of old friends of the candidate, who had heard him in similar places devoted to him during the last 20 years, and before he was known as a presidential possibility. With the conclusion of his tour, Mr. Bryan himself was being greatly pleased with his reception in his home state during the day, saying that his audiences were larger and more enthusiastic than during any other campaign.

Three congressional districts were traversed today, and in each one the candidate made an appeal for the Democratic nominee. He lavishly began his speech by saying that he was more interested in the election of the candidate for Congress than in the election of the Democratic nominee. At those places where it was possible to do so, Mr. Bryan discussed all the issues, but in smaller places he devoted his time to explaining and defending the Democratic position on the guarantee of bank deposits. At Columbus he took up the question of insurance when the subject was first suggested, and compared the arguments presented then with those now urged by the opponents of the guarantee plan of the Democratic party.

When Mr. Bryan retired tonight at Hebron he expressed himself as being in the best physical condition of any campaign. He has so far spoken 47 times in the last two days, and is apparently the least affected by the hard work of any man in his party. The state committee has assigned 18 speeches to him for tomorrow, but in all probability the "extras" will bring that number up to 25.

AMERICAN CANNED MEATS PURER THAN BRITISH

Washington, Oct. 15.—The medical department of the local government board in Scotland, in a report covering analysis of British and American meat foods packed in this and glass, sets forth facts which go a long way toward discrediting persistent rumors circulated abroad against the purity of American meats according to Consul Maxwell Blake of Dunfermline. The investigation disclosed that a large amount of hams and bacon of British origin are converted into a prepared food, a large amount which is found on analysis to contain boracic preservatives. The examination of samples disclosed that American products contained only 15 per cent preservatives, while British products contained more than 40 per cent. The British manufacturers attempted to contradict the justice of the findings on the ground that many of the products used for canning purposes were of American origin. The official report, however, contradicted this contention.
