

# Operators Agree To Arbitration

Differences Between Them and Coal Miners to be Submitted To a Commission of Five Persons, to be Appointed by The President of the United States—J. P. Morgan Chief Factor in Securing Agreement.

Washington, Oct. 13.—By authority of J. P. Morgan, who, with his partner, Robert Bacon, and Secy. Root, was in conference with President Roosevelt at the White House tonight for the purpose of settling the coal strike, a statement was given out by Secy. Root, in which the president of the United States proposed a commission of five persons to adjust the differences and settle the coal strike in the anthracite fields of Pennsylvania. The proposition is believed by the administration to be satisfactory to the miners, as it covers the proposition made by President Mitchell of the United Mine Workers' union, with additional conditions, which, it is believed, the miners will accept. The statement follows:

## UNDEVELOPED COAL LANDS.

Chicago City Council Asks Congress To Obtain Control of Them.

WOULD BREAK MONOPOLY.

Committee Also Solicits That Congress Shall Employ None but Union Laborers.

Chicago, Oct. 13.—A resolution was unanimously adopted tonight by the city council memorializing Congress to obtain control of undeveloped coal lands in order that the monopoly may be broken by competition with the government.

It was also decided to establish a board to be known as the "City of Chicago anti-trust or monopoly commission," to consist of three lawyers, to investigate at once the legal aspect of the coal strike. The members are to be appointed by the city council, and they are authorized to seek to apply the federal laws or those of the state, which may be applicable, in order to bring about a cessation of the labor difficulties in the anthracite region and to break other monopolies.

Separate from this action the councilmen also decided to ask Congress to employ none but union laborers in the development of the undeveloped coal territories, purchase of which was petitioned for.

## ALMOST BEATEN TO DEATH.

A Mob Attacks a Non-Union Man With Clubs and Stones.

Scranton, Pa., Oct. 13.—Orlando Schooley, who was taking a crowd of newly recruited men to work at the Edgerton colliery in Jersey this afternoon, was set upon by a mob of 100 and beaten so badly with clubs and stones it is feared he will not live. When taken to the emergency hospital at Carbonade it was found that his back was broken. The recruits who were with Schooley were allowed to go unharmed upon their agreeing to take a train out of town. They said they came from Noxon, Wyoming, and that they were there to be given jobs as firemen at \$2 a day. A company from the Thirteenth regiment camp at Edgerton arrived at the scene of the assault on a special train after the mob had dispersed.
