

PRESIDENT LOUROURO'S ADVICE.
He is "Not in Sympathy With the
Hunters Against the Snake
Skins."

President Lourouro of the City
Council has an eye to business from a
protectionist standpoint that is ex-
tremely happy. This is how he ex-
pressed himself last night: "I have
not the slightest sympathy for the
hunters against the snake skins
and their newpaper supporters. If
these people really want to get
rid of the snake skins, let them do it
now and bring him a good fee to
help into the meter and make the
mysteries of snake skins skins
come to light. That is the only way
for an effective remedy."

Mr. Lourouro informed himself by
learning that the "hunting
against the snake skins" was
nothing but the talk about the necessity
of compelling the use of snake skins
exempt. He followed up by asking
"Who knows but what the snake skins
make just as good leather as
the skins of any other animal?"
