MARRIED IN SALT LAKE.

He Quarreled With His Bride, Left Her, Went to Doctor and Was Suspended.

Charles J. Johnson, of the past seven years employed in the government survey in the West, was found in a dying condition at his home, 1802 Alpine street, at 11:30 yesterday afternoon, says the Deseret News of Friday, the 11th inst. He was removed to the county hospital, where he died at 12:30 last evening.

Little is known of Johnson's history. He has been in Denver since September, coming from Salt Lake City. There he was married about a year ago, but left him in September, after living together a few weeks. Johnson had been working at the surveying and would sit ten hours, resting in intervals with any one, according to neighbors with any one, according to the final arrangement and his hurried come to Colorado. He returned from a trip to Cheyenne, Wyoming, on the night of Sept. 27th, applied at 1802 Alpine street, a rooming house kept by Mr. and Mrs. F. V. H. Hohmann, and remained there until yesterday afternoon. He had been attempting to make several nocturnal attempts, succeeded in pushing the key from his door when Johnson was found breathing heavily, the police were notified and the surgeon ordered the body removed to the hospital.

Johnson sank to unconsciousness and was taken to his room in a moment of depression. He left no note, and when his friends were asked what he had done, it was the example of a man surveying out a road, who had given up his work and had no money to live on.
