MONGOLIAN PROFLIGACY.

The Western press, as well as the Eastern telegraphic despatch, occasionally contains accounts of outrages committed by the hoodlum and other portions of the antagonistic Caucasian element upon the Chinese residents of California, and it is well known that on account of the competition which they have caused in the labor market, the feeling against them in the State is very high, and is continually increasing, and there is little doubt that that class of immigration continues, the aid of Congress will soon be invoked to stop it, or to limit it within certain bounds. Such a contingency seems anti-slavery in character, and it is seriously contrary to the popular notions. But while bread and butter are the necessities of life in question, and considered by the immigrations of thousands of acknowledgedly inferior race, some incompatibilities may be expected and experienced. It is this prospective contingency which has given rise to the strong anti-Chinese feeling in California, and in other portions of the country.

In theory, that is the United States is regarded as a home for the toiling millions of all nations, or, as many often choose to make it, so, but precisely the same principle is operating here as in older countries, so far as capital and labor are concerned, and in many portions of the country the labor market is overstocked, and there is consequently almost as great a struggle among the masses to procure the comforts and necessities of life as in Europe. For some years past this has been strikingly exhibited on the Pacific Coast, for thousands of Chinese have immigrated thither from their own country, and being handy and skillful in many branches of industry, the excess of very cheap labor thus introduced has undoubtedly driven out the master but scarcely more skilled white labor, and hence the irritation and abuse to which the Chinese immigrants have been subjected.

So far as my information is concerned there seems to be no more right to deprive the natives of China of the privilege to come to and settle in this country, than the people of any other foreign nation, or, indeed, the Constitution of China, the Parrot of the worshippers of Peata and the Mahometans of Mecca, or Africa, or America, or even the priests of the Christians of Europe, and no one could object to such use against the former than the latter. As for the political or economical questions that may arise therefrom we shall not attempt to discuss them now, the country we believe is large enough for all, and the many other questions of a similar character which have arisen at various times in European countries, time and experience alone can solve them satisfactorily, if they are ever solved at all.

But Chinese immigration may be a political question which will demand some attention and discussion, so far as religion and civil rights are concerned, the Constitution no more debar the Asiatic than the European. But if immigrants from Asiatic or any other country, seek to introduce any established religion, we believe the exercise of the law is necessary.

Our Western despatches yesterday and to-day, M. reliable, and there is no particular reason to doubt them, show that what they say really did occur, that the Chinese, who were the most numerous in the city, were driven out of the city, and in respect to whom they are fully the equals if not the superiors of their white neighbors.

A sale of Chinese women, like slavery itself, is no longer permitted, and a feature of the Chinese social system, which used to be tolerated, has since its rise took place in San Francisco, day or two ago, the young women, reaching as high as \$150, the trifling sum from \$10 to \$20. These very women, however, are now seen, can not be allowed in the United States, and the Chinese themselves say, that now they are compelled to leave the country, and no longer remain in the United States borders, and the Chinese of California should be made to understand this principle, and to permit a return if they consent to do so.

Such an interval of time should be given in which to do this, and the Chinese should be allowed to return to their native land, where they can live in peace and quietness, and not be compelled to leave it.

But bad as is this course, it is, however, a salutary lesson, and we hope, if possible to repeat it, and the discovery of the existence of a great Chinese society in San Fran-

cisco, whose only object is the traffic in human beings, and the debasement of women. This is an enormity unknown before in our history, and we can wonder if the anti-Chinese feeling should become so intense, and induce us to do so. If the Chinese fail to emigrate to this country, we believe they have the same right to do so as foreigners in any other country; and if they believe them selves as well as their citizens they have the full measure of privileges enjoyed by any other class of our heterogeneous population. But vices and crimes which come in direct conflict with the supreme law of the land and with a correct popular sentiment, should not be permitted an abiding place on our shores, and the sooner those who endeavor to introduce and establish them learn this fact the better.

SAN FRANCISCO, 30.—The police, to-day, unearthed a Chinese secret society, known as the Ho Yen, who carried on a traffic in Chinese females for prostitution. One Yat Lung, having married a Chinese girl who was a slave, and was brought up in a house of prostitution, was compelled to pay the keeper of the brothel \$350, on pain of death. He escaped, and reported the facts, and to-day seven members of the society were stripped naked and held up from the balcony in full view of the hawking men below. Their names, however, were not given. The mob was asked whether it would have them dead or alive, and according to the answer either their heads were off, and their hands cut off, or they were thrown down the balcony, or they were thrown down still alive, the mob below trying to catch them as fall on bayonets and stakes, and everybody then shouting, "Kill them, kill them." What remnants of life were left, or, if too late for this, to further mangle and disfigure the unfortunate bodies.
