POLICE RAIDS!

Sudden Descent Upon Violators of the Law.

CAPT. DONOVAN ARRESTED.

Two Big and Noisy Feeling Among the Officers.

THE SENSATION OF THE DAY.

Our Mail Boxes Were in the Box—What the Officers Say to our New Master of Enforcing Moral Ethics.

The most extraordinary and exciting incident that ever occurred in the quieted condition of the social evil section in this city was reported in yesterday's news.
