A CHRISTIAN SERMON (?)

We find it necessary, once in a while, to notice the frantic endeavors of two or three religious publications to prejudice the country against the Latter-day Saints, or "Mormons" as they choose to name them, with the ultimate object of bringing religious influence to hear on the Senate of the United States, in order to deprive a Senator from Utah of the seat to which he was lawfully elected by the representatives of the Republican party in this State. It is a little curious to note the manner in which they deftly mingle religion and politics and bring to bear the power of their church over the affairs of state, while at the same time they berate the "Mormons" for exercising that kind of control, which they untruthfully attempt to show is a

feature of the "Mormon" system. The most recent attack upon "Mormonism," with the same object in view. appears in the Christian Herald of January 17, 1906. The copy which has been furnished to us is doubtless an advance issue, as the paper is published in New York, and has been here at least two or three days. It purports to be a "Sermon by Rev. F. De Witt Talmage, D. D.," written apparently for that paper and not yet delivered from the pulpit. It consists chiefly of a tirade of abuse, plagiarized stories, extracts from newspaper libels, incorrect pretended citations from congressional and state laws, distortions of "Mormon" doctrine, echoes of the pleas of men and women who know nothing of the question at issue, to debar forever from the congressional halls every representative of "Mormonism," and a general repetition of untruths long ago exploded and cast aside by well informed opponents of the Church of Jesus Christ. of Latter-day Saints.

lenged Brigham Young to a debate with him on the polygamy question, and President Young referred him to Orson Pratt, who arranged with Drs. Newman and Sunderland for a discussion of the question in the Tabernacle. The debate was reported verbatim. The proceedings were detailed in the local papers. Nobody ever heard of such an outburst as described in the Christian Herald, until it appeared in that religious magazine. Dr. Newman made a terrible mess of his attempt to prove that polygamy was not taught in the Bible and was not practized by Moses and the patriarchs. And the only expression of the congregation in response to one of his labored, flat and flabby attempts at a flight of oratory was on one occasion, when he hemmed and hawed so, in evident hesitation at not being able to recall the grandiloquent words he had committed to memory, that the audience fairly roared with laughter.

There are many people in this city and state who were present during the debate, and we presume there is not one of them, whether friend or foe, who remembers any such incident as that which Talmage declares Dr. Sunderland related to him, or would have the hardihood to declare that it occurred. Dr. Sunderland rendered all the aid he could to support Dr. Newman, posting him frequently with quotations which he desired to use, but the whole affair was a recognized failure, and the challenger beat a retreat with as good grace as possible.

To his great surprise, he found that Elder Orson Pratt, one of the Twelve Apostles, was a Hebrew scholar, thoroughly versed in ancient scripture, and when Dr. Newman cited Leviticus xviii, 18, as the grand Biblical fulmination against polygamy, and endeavored to distort the Hebrew text in order to sustain his position. Elder Pratt so thoroughly analyzed that text from every possible standpoint, that the great champion of the M. E. church in Washington, D. C., "with the chimes attached," was completely vanquished, and even the boys in town jocularly referred to him after his departure as "Leviticus xviii, 18."

Dr. Newman was treated with the greatest courtesy while here, and as far as we know, the story batched up by F. De Witt Talmage D. D. is the first attempt from any quarter to show to the contrary. There was no occasion at any time for the exercise of the influence of President Brigham Young to preserve order during that debate. The writer of this article was present, and knows of that which he affirms, and his statement can be corroborated by many other persons who also attended.

We do not intend to go through the so-called "sermon," published in the Christian Herald, but will quote a few sentences to show the kind of a "Christian" preacher this later Talmage is. After stating that he has read many books, "both for the advocacy and the condemnation of Mormonism," he remarks:

"I can come to but one conclusion: that Joseph Smith was a crack-brained epilepite, who with his fits of hysteria, was just the man for a little while to appeal to the ignorant and superstitious people with whom he came in contact." It is just the same with his denunciation of the tithing system, which he denominates as "graft." Every statement he makes concerning the "enforcement" of that principle is entirely untrue. He either knows nothing at all about the doctrine, spirit and discipline of the Church that he berates in language unfit for the pulpit or for any real Christian publication, or he wilfully and intentionally perverts

that which he attempts to bedaub with the mire of his own manufacture. We have only given a few samples from the mess of mendacity which he calls a written sermon. The nub of it all is contained in the tail end like the sting of a wasp. It is this: Expel

Reed Smoot from the Senate of the United States, because he is a member of the Church thus abused and stigmatized and misrepresented. We have already devoted too much time and space to the scurrilous concoction by a preacher who appears to be aiming to acquire fame, but who will never reach the position acquired by the elder Talmage, while he devotes what few little talents he possesses to the shameful work of holding up to scorn and derision, and still more forceful antagonism, a Church and a people whose faith and devotion he is not able to comprehend, and against whom his puerile efforts will fall and will fall back into the mire from which they

Ten thousand angry men and women instantly leaped to their and women instantly leaped to their feet and began to press down toward the platform. him! Lynch him new! him! Lynch him new! "I sat beside Newman at the time," continued Dr. Sunderland, "I did not see one avenue of oscape. Suddenly Brigham Young arose and stepped to the front of the platform. He swum his arms out over that cursing, swear ing, angry mob and uttered just two words: "Sit down." They dropped into their seats as the srain falls before the hiss of the scythe. That was to me the most marvelous scene I ever wit-nessed. As I came under that leader's world they have so me of the ressed. I realized that he was one of the greatest of men and one of the most dangerous, if not the most dangerous to American Iberties, who has ever trodden American soil."
