### Lengthy Detention of Judge Woods in the Case of Railway Union Officers.

## Chicago, Dec. 14.—(Daily)

As charged by the grand jury, Judge Woods, United States District Judge of the American Railway Union, was today sentenced to six months' imprisonment for contempt of court. The same finding was returned against other American Railway union leaders on trial with Debs.

Judge Woods' defense averring the chain of the defense that the injunction against the A. R. U. leaders was invalid on the ground that the court had no jurisdiction to determine the case in which the injunction was issued.

Debs was sentenced to six months in the county jail. The others were given three months each except Mr. Vane, who was released because there was no evidence against him.

## THE TREATY WITH CHINA.

### It Will Undo the Provisions of the Geary-McCreary Act.

San Francisco, Cal., Dec. 14.—The new treaty between the United States and China, which is about to be signed by the President, will virtually undo all the benefits we have derived from the Geary-McCreary act, said U. S. District Attorney Carter.

Under existing laws a Chinese laborer cannot leave his country and return to his native land, and the United States would be obliged to receive him.
