AMERICAN.

WASHINGTON, 15.—The Warm Spring Indians, now in town, had another conference with the Commissioner of Indian Affairs this afternoon; they want the Commissioner to furnish them with transportation to their homes in Oregon, in view of their services to the government in the Modoc campaign. The Commissioner will probably accede to their request.

In the U. S. Supreme Court, today, the case of *Sty Hung*, from the California circuit court, involving the question of the importation of Chinese females for immoral purposes, was set for a hearing on January 11th, 1876.

The Commissioner of Internal Revenue, in his supplementary report, in speaking of how unequally the taxation upon savings banks is distributed among the States, says that—"Upon a given amount of capital and deposits the tax on California as compared with Massachusetts is as ten to one; on Michigan, as compared with the same state, as sixteen to one; on Virginia as compared with Vermont, as five to one. The city of New York, possessing a taxable capital and deposits of fifty million dollars less than Maine, New Hampshire, Vermont, Massachusetts and Connecticut combined, pays a tax three times as great as these states, while these same states, having a capital and deposits three times as great as California, pay about one-half the tax that is paid by California."

Vice President Wilson continues to regain strength rapidly.

The U. S. Supreme Court did not deliver any opinion in the *U. P. R. R.* case to-day. One of the justices is authority for stating that all the current reports relative to the determination of the case by the Supreme Court are without foundation.

NEW YORK, 15.—The Rev. Dr. Buddington said, to-day, to a Brooklyn reporter, that he thought Mrs. Moulton was justified in calling for a Congregational council to settle the difficulties between herself and Plymouth Church, and he believed that such a council would be called. Of course, it will be *ex parte*, as Plymouth Church will refuse to attend.

The ship *Raven* arrived to-night, and reports that on Oct. 26th she took ten men from the brig *Morue*, from St. Pierre, bound for San Salver, France; the brig had capsized the day before during a gale. The men say that she had seventeen passengers and a crew of twelve, and that thirteen passengers and two of the crew were lost.

The National Fall Billiard Tournament, at a three ball game, was commenced at Tammany Hall, by the two Dions; there are twenty-one games to be played, 300 points each; four prizes are offered as follows—1st prize \$1,500; second \$1,000; third \$650, and 4th \$350.

BROWNSVILLE, Tex., 15.—The federal grand jury, in their reports, say that from Brownsville to Pecos, a distance of six hundred miles in length, and a hundred and fifty to Nueces, the American ranchers have been ordered to leave their homes, by Mexican raiders, on pain of death, and that a hundred thousand head of stolen cattle are driven to Mexico annually by Mexican marauders. Numbers of federal officers have been assassinated, post offices burned, custom houses robbed, and mail carriers and inspectors of customs killed while in the discharge of their duties, and the perpetrators of these crimes have gone unpunished, and a general insecurity of land and property prevails on the border.

MEMPHIS, Tenn., 15.—Extensive preparations are being made for the Texas Pacific Railroad convention, which meets here on the 19th inst. Most of the Southern States and several of the Western ones

have appointed delegates, and the indications are that the convention will be well attended from all the sections interested in that road.

UTICA, N. Y., 15.—Burke & Hely, bankers, of Little Falls, suspended yesterday, and make an assignment to J. W. Cronkhile, of that village; their liabilities are about \$100,000; their assets are supposed to be small, but include an \$80,000 opera house block and a banking house in Little Falls. Burke's Bank, of Utica, is indirectly connected with this firm, and will be obliged to suspend for a few days.

ST. LOUIS, 15.—The case of Gen. J. McDonald, ex-supervisor of internal revenue in this district, was called in the U. S. District Court, to-day; his counsel endeavored to have the case laid over a few days until certain papers could be received from Washington, but Judge Treat declines to grant the request, and a jury was empaneled and the prosecution opened with a statement of the case by assistant U. S. Attorney Paddock, the government counsel in these whiskey frauds.

SAN FRANCISCO, 15.—In the *Bulletin-Alta* libel suit, the motion of defendant to strike out that portion of the complaint referring to the Bank of California was granted to-day.

A dispatch from Tucson, Arizona, reports that in a fight between the revolutionists and government troops near Altur, Sonora, the latter were defeated, with a loss of six killed and a number wounded and taken prisoners.

Dispatches from various points of Southern California to Arizona, report a smart shock of earthquake at half-past 2 this afternoon.

FOREIGN.

STOCKHOLM, 15.—A serious railway collision occurred on the road between Linköping and Linäkeberg; ten persons were killed and twelve more or less injured.

PARIS, 15.—The ship *Lennie* has arrived at Rochefort. All the sailors on board were arrested.

The Greek sailors who fled from the ship *Lennie* have been examined at Rochefort; the youngest of them confessed that the officers were murdered in British waters, under circumstances of great atrocity.

In the Assembly to-day, the debate was upon the motion of M. Delacour, for the postponement of the consideration of the municipal law till after the general elections. M. Duprat and other republicans opposed the postponement and charged the government with designing to influence the elections through the mayors, who, according to law, are appointed by the government. M. Buffet refused to abandon the mayors, to whom the government is indebted for their devoted services, and said the elections will be free and straightforward. The government has a right to make known and support its opinions at the elections. The party of the right cheered enthusiastically at these utterances; the left, regarding the speech as a defence of the system of official candidates, were greatly irritated. The postponement was then voted by a large majority.

The reading of the electoral bill has been fixed for Friday next.

SANTANDER, 15.—One thousand troops embarked here for Cuba to-day.

MADRID, 15.—The *Correspondencia*, of this city, states that the reply of Spain to the recent note of the U. S. in regard to the treaty of 1795, will defend the rights of Spain with energy but moderation; it will express a hope that in her desire to maintain good relations between the two countries, Spain will meet with reciprocity.

El Cronista, the ministerial organ, says it believes that the questions which have arisen between Spain and the U. S. with relation to the treaty of 1795, will terminate in the establishment of an agreement.

LONDON, 15.—The *Mark Lane Express*, in its weekly review of the corn market, says that recent unfavorable weather has much impeded field work, which was already much in arrear. The condition of samples has considerably deteriorated. This, with a continuance of heavy foreign supplies, has militated against the price of wheat. Several markets have declined a shilling per quarter, while all are more or less dull. At Paris the best wheat, owing to few offers, has advanced a shilling per quarter. Complaints come from the home

market, as well as from those of Holland, Belgium and Germany, of short delicacies with hardening prices. In Austria the wintry weather and generally short supplies have occasioned a rise in wheat of from one shilling to one shilling and sixpence per quarter. Should the present early frosts herald a severe and long winter we must expect to witness an advance in prices notwithstanding the present heaviness of the granary stock.

The estimated damage done in London and neighborhood by the high tide, to-day, will reach fully \$5,000,000.

FLORENCE, 15.—The libel suit of Connelly versus Healy, arising from charges of art frauds contained in letters of the latter to the *N. Y. World*, was decided to-day; the court, taking into consideration that justification could not be accepted by the law as a defence of the libel, sentenced Healy to a fortnight's imprisonment and a fine of 1,000 lire, and the manager of the *Tourist* newspaper to eight days imprisonment and a fine of 500 lire, for publishing the libel. Both parties have given notice of their appeal from the decision of the court.

The New York papers are dwelling with pensive fondness over the period in the history of their city from the beginning of 1870 to the end of 1872. During that oasis in the desert of their lives there was no lack of items. The *Times* says there was an average of one murder a week, with other crimes in the same excessive proportion. During these three years of plenty there were only 2,769 convictions, and still fewer punishments. Small wonder that New York is obliged to have an "Inquiry into the Causes of Increase of Crime," and a set of legislators to do the inquiring.—*St. Louis Globe Democrat*.
