An event has just occurred in
England, attracting little notice
here, which if it happened in this
country would be hailed as the dawn
of a political millennium.

Lord Henry Lennox has resigned the
office of Commissioner of Public
Works for no stronger reason than
because Lord Chief Justice Coleridge
indirectly censured (not by name)
his connection as director with a
speculative and ruinous
scheme, the Lisbon Tramway Co.,
one of Lord Grant's buildings.

No parliamentary committee had
been appointed to investigate his
relations to that alleged fraud, and
note was taken of Mr. Disraeli's
conduct in the House.
