WESTERN DISPATCHES.

MADRID, 6.—Congress has rejected
the motion for the immediate consider-
ation of the bill for the relief of
Sagasta. The Republican bands of
Catalonia are dispersed.

LONDON, 7.—A meeting of Ameri-
cans was held at the Hotel de la Paix
to-day, to discuss the bill for the relief
of Sagasta. The bill was passed by
the House of Commons to-day.

NEW YORK, 7.—The Bank statement

by law.

BOSTON, 7.—The executive and gen-
eral relief committee of the State
state that the central relief com-
mittee, have charge of the persons burnt
out, comprising between 400 and 1,000
families. The committee for the re-
lief of men thrown out of employ-
ment received and investigated one
thousand five hundred applications,
and the committee for the relief of wo-
men thrown out of employment received
and investigated four thousand
three hundred applications, and have
severally given aid to all the applicants
who deserve and needed it. They have
continued to do so for some weeks. The
committee on aid will require an ad-
ditional sum for the proper completion
by them of the work. A careful esti-
mate of our future needs leads to the
conviction that not less than
\$150,000 will be required to give
relief independently of the special
fund for firemen. The sum at the dis-
posal of the general committee is about
\$50,000, which will be exhausted in ten
or twelve days; we therefore feel it our
duty to make known the importance of
raising one hundred thousand in ad-
dition to the sum already sub-
scribed. We contemplate with reli-
ciance, which will be generally shared,
as the only way of raising the sum
making an appeal to other cities for aid,
because we believe the people of these
cities are perfectly able to meet the demand
without difficulty, and that they desire
and ought to do so.
