

SOCIALISTS PUT UP EUGENE V. DEBS

Platform Demands National Ownership of Public Utilities and Industries of Nat'l Scope.

CALLS FOR SHORT WORK DAY

Would Abolish Senate and President's Veto Power and Make Constitution Amendable by Majority Vote.

Chicago, May 15.—Eugene V. Debs of Indiana this morning was nominated for president on the first ballot by the Socialist party national convention.

Benjamin Hanford of New York was nominated by the Socialists for vice president.

Socialist party delegates held the first night session of the convention which has been in progress here since last Sunday and took up tonight the reports of committees on resolutions and platform.

After several hours debate the platform had not been formally adopted when adjournment was taken until tomorrow.

The draft of the platform as presented to the convention, however, represented the unanimous views of the committee members, and it is believed will be accepted practically in its present shape tomorrow.

The demands set forth in it include national ownership of public utilities and of all great industries of national scope "in which competition has virtually ceased to exist," extension of the public domain to include mines, quarries, all waste forests and water power, and scientific reclamation of timber lands and reclamation of swamp lands.

Touching the labor situation, it calls for a shortening of the work day, the securing to workmen of at least a day and a half each week for rest; prohibition of employment of women in harmful vocations and of children under 16 and forbidding interstate transportation of state product of child labor, convict labor and the products of unsanitary factories.

A demand is made for the abolition of the senate and of the veto power of the president, and that the constitution be made amendable by a majority vote; that all judges be elected by the people for short terms, and that the power of injunction be curbed by immediate legislation.

In the preamble to the platform it is charged that capitalists control the dominating parties and through them the elected public officials.

"They select our executive," is the declaration made, "bribe our legislators and corrupt our court of justice. They own and control the press. They sway our educational institutions. They govern the nation politically and intellectually, just as they own it industrially."

In closing, the preamble reads: "In the battle for freedom the Socialist party does not strive to substitute working class rule for capitalist class rule, but to free all humanity from class rule and to realize the international brotherhood of man."

THE FRANCIS CUTTING.

Fished in Three Mile Limit, Seized by Canadian Authorities.

Vancouver, B. C., May 14.—Found fishing inside the three-mile limit at the north end of Vancouver Island, the American steam tugboat Francis Cutting, owned by the Seattle Fish & Cold Storage company, was seized by the Canadian fisheries cruiser Keen.

Commander Newcombe wired Ottawa this morning and the tugboat was ordered to be taken to the vessel is to be confiscated, the owners having the option of fighting it in the courts if they wish to. As the Francis Cutting is a well built steamboat, worth about \$30,000, the capture is an important one.

UNDER SPECIAL RULE HOUSE PASSES VREELAND BILL

Washington, May 14.—The Vreeland currency bill, agreed upon by the Republican caucus, was today put through the house under a special rule by a vote of 184 to 145. Fifteen so-called insurgents of the majority voted with the Democrats, who went on record solidly against the measure.

The closing moments of the debate were replete with excitement and Republican enthusiasm caused by the refusal of the great majority of the Democrats to go on record for the Williams bill, which had been offered by Mr. Kahn of California as a substitute for the Vreeland bill, in accordance with a well laid plan of the majority to stand by to ascertain where the Democrats stood.

With one accord the prosecuting officers of the county declared today that these relics are the most valuable to their case that have yet been discovered.

The bones were found by the men who have been sifting the ashes in the cellar of the house.

When the sifting process began several large pieces of metal and a watch case rattling down the screen, Sheriff Smulzer at once ordered one of the men to sort over the larger pieces and late in the day two pieces of human jawbones were found. The piece of skin was also found by this method, the late discoveries coming after the men had begun work on the portion of the cellar where the bodies had been.

There was a hurried call for the physician who has been assisting the coroner when the specimens were brought to town. The meeting was held in the office of Dr. J. H. William Meyer.

"The piece of bone are from the upper jaw of a human being," said Dr. Meyer this evening. "One seems to have been from the right jaw and the other from the left, although this point has not yet been determined. It is impossible to determine the nature of the skin or hair. It may have come from some of the bodies which have been a portion of some one's scalp."

Today's findings also included several charred vertebrae, but this value is doubtful.

Over 200 letters of the crank variety were received by the sheriff, the coroner and others today. Some of them offer to produce Mrs. Guinness for a consideration.

STREET RY. ACCIDENTS.

New York, May 15.—According to reports compiled by the public service commission, there were in April 4,767 accidents upon the street railways, subways and elevated roads within its jurisdiction. This shows a steady increase since the beginning of the year. In January there were 3,321 accidents; in February, 3,351, and in March, 4,353. Altogether there were 2,386 persons hurt. Of these 1,671 were passengers, 652 persons not passengers and 563 employees. These figures also show an increase of the persons injured in April 30 died.

He will be identified before United States Commissioner Heacock and an order obtained transferring him to Chicago for trial.
