Supreme Court Decision, in the Case of the State vs. Orrin Porter.

HE WAS CONVICTED OF BURGLARY.

And Sentenced to Three Years' Imprisonment. Yesterday Afternoon, in the Supreme Court on Appeal.

Chief Justice Kane delivered an opinion today in the case of the State vs. Orrin Porter, appellant, reversing the judgment of the court below and ordering a new trial.

Porter was convicted before Judge Hodge of the crime of burglary and sentenced to three years' imprisonment. The case was brought up for review in the Supreme Court on appeal. The case was argued by Porter's counsel, and the court was divided 4-4 on the question of whether a new trial should be granted.
