The charge against George Hinde having been changed from assault with intent to kill, to one of assaulting a deadly weapon, the defendant was given a hearing in the police court yesterday afternoon before a jury.

George Hinde, the witness who was shot, said he had been shot by John Freeman, the man who was in the house at the time of the shooting, was exonerated in the stand.
