### CRUSHED BY LOCOMOTIVE.

Charles E. Maynard Meets Shocking Death in Depot Yards.

Was an Old and Respected S. P. Employee - Peculiar Horse Deal - Funeral of Charles Driver.

A shocking railway accident occurred yesterday morning by which Charles E. Maynard was killed, at the railway crossing on Twenty-fourth street by a switch engine.

Mr. Maynard, who has been boarding at Mrs. Hammond's, 106 Twenty-fourth street, left the house at about 7 o'clock to go to the Southern Pacific round-house, which is situated in the depot yards, where he was employed as foreman. He was carrying an umbrella, as it was raining, and it is supposed the umbrella obscured his view, and he was struck by the engine, which was pulling an express car, moving at a good rate of speed. The switch engine was run by Engineer James Brown, who has been in the employ of the Southern Pacific for a long time, and is considered a careful man. There was no one on the engine, and the fact that it was running on a main track, where it was not supposed to be, is a mystery.

Mr. Maynard was 62 years of age at the time of his death, and was one of the most highly respected employees of the Southern Pacific. During the last 15 years he has been employed by the company, and for a number of years as foreman of the depot yards. He was a native of Ohio, and had a family living here, consisting of a wife and three children. He was a member of the Methodist church, and was a very active worker in the church. His death is a great loss to the community, and his funeral will be held at 2 o'clock.

Second-Whereas, We favor the ceding of the natural waters of the valley to the people, to be governed by cities, towns, villages and other smaller reserves; now, therefore, be it

Resolved, That the people of Sanpete county, in an irrigation convention assembled, that we protest against such wholesale and, as we think, such unnecessary withdrawal of such vast tracts of the public domain from the people, for the reason that such withdrawal must work great and irreparable injury to our state without being correspondingly beneficial. It will retard the development of our mineral resources by excluding the miners from such tracts of land; it will retard our agricultural developments by excluding the farmer and homeseeker from the lands of the public lands, and harass the farmers in obtaining from such reserves their necessary fuel and timber with which to improve their domestic stock; it will be destructive of the sheep and stock industry of the state; it will render almost impossible the magnificent land made by the government of the United States to the state of Utah, in that the lands thus withdrawn comprises nearly all the valuable, vacant public lands within the state, and out of which such lands so granted could otherwise be selected and sold by the state.

It is unnecessary, because large portions of the land thus withdrawn are devoted to timber, and there are no watersheds to be conserved on large portions of said reservations.

Resolved, That we favor the conservation and protection of the watersheds and water courses of every city and town in the state, either by the establishment of timber reserves or otherwise, and that we recommend that such forest reserves, watersheds and water courses be under the immediate control and supervision of the respective municipalities concerned therein, that reasonable and definite limits to such reserves be established, and that the remainder of the reserves heretofore established be restored to the public domain.
