COURT PUTS BAN ON SHOWY FUNERALS

Judge Howell Rebukes Ostentatious Displays Made at Expense of Helpless Orphans.

W. C. T. U. ELECTS OFFICERS.

Cause of Temperance Strongly Advocated—Suits for Divorce—\$2,000 Damage Case—Weddings.

Ogden, Oct. 16.—Judge J. A. Howell is very much opposed to expensive funerals, and announces that in the future he will refuse to allow any funeral which he considers in excess of the financial standing of the estate. The matter came up in open court for his approval of the bill against the Frank S. Lowe estate. In passing upon the matter the judge expressed himself in the following language:

"In this estate, which is shown by the petition to consist of a little house in which the family live and the sum of \$1,200 in money, a claim for funeral expenses in the sum of \$350 against the said estate is presented to me for approval."

"The wasteful extravagance and ostentatious display being indulged in by people nowadays in funerals of their deceased relatives, the last on the part of the family suffering the latest loss by death to outlive in magnificence the funerals of their neighbors' families who have suffered a prior death, not only furnishes a subject for adverse comment upon the status of our civilization, but when it is indulged in at the expense of innocent little children, depriving them of the means for their sustenance and education, to which they would otherwise be entitled, it becomes such an unmitigated outrage that I do not feel that I ought to add judicial sanction to it. In this case the amount of money in the estate being so small, apart from the little house which constitutes the home of this family, it seems to me that I would be neglecting to my trust if I approved this claim for such a prodigious amount and thus deprive the two little children to whom a portion of this money belongs of what but for this expenditure they would be entitled to receive.
