New York, Oct. 10.—At 10 o'clock this morning a seven story building in course of erection at 473 Madison street, was blown down by a cyclone. It contained a laundry building, No. 72, where two families with boarders lived. They were buried in the ruins. Six of them were taken out dead and nine injured. Only one dead body has been identified. It is that of Bertha Kline, aged 20. The other victims are a head man by the name of William, aged 40, and a woman, aged 30.
