Cedar City Wants Water—Cedar City has filed an application with the state engineer for water from Coal Creek to irrigate several thousand acres in the neighborhood of the town from May 15 to Nov. 30 of each year.

Pay Day in City—Yesterday was the regular semi-monthly day of payment for various city departments, and Auditor Alf and his assistants were kept busy handing out checks. The payrolls aggregated \$17,872.62, as follows: Fire department, \$4,864.52; police, \$5,699.59; officials, \$5,494.92; post office library, \$630; city councilmen, \$750; board of public works \$583.30.

INSPECT DETENTION HOME.

The Uintah school building, which has been chosen as a detention home, was visited yesterday by Judge Gowans of the juvenile court and Probation Officers Brown and Thompson. The structure is very much in need of repairs, and contractors will be asked to submit bids for putting the roof in good condition for the immediate use. The site is considered to be ideal for the home, and an endeavor will be made to provide additional funds as the needs may arise.

In view of the above, the following circular letter was ordered sent to property owners in streets which it is intended to park:
