NEWSPAPERS COMBINE.
OGDEN, May 11.—The Utah State Journal, an evening paper and the Morning Examiner of this city will be consolidated and beginning next Thursday morning will appear as a morning newspaper. This is the statement that was published last evening in local papers, including the State Journal.

The Examiner-Journal will be the name of the combined papers, and it now means practically the absolute control of the newspaper field in Ogden by William Glasman, publisher of the Standard and formerly publisher of the Examiner. In the new company Glasman has one-half of the stock while Bert R. Bowman and A. R. Bowman have the other half. The division of the stock will be as follows: A. R. Bowman, \$2,500; B. R. Bowman, \$5,000; William Glasman, \$10,000; J. G. Bond, \$2,400; D. T. Tracy, \$100. The latter two are connected with the Standard. The officers will be J. G. Bond, president; Bert R. Bowman, vice president; D. T. Tracy, secretary. A. R. Bowman will be manager.

On last Saturday the Bowmans bought the Journal and took immediate charge of the same. They issued their first paper last evening and editorially announced the consolidation with the Examiner. It is announced that the new paper will be Democratic in politics and will have the full Associated Press dispatches.

NEW CANNERY FOR OGDEN.
OGDEN, May 11.—Articles of incorporation of the Wright-Whittier company have been filed with County Clerk Dye. The capital stock is \$50,000 with shares of the par value of \$100 each. The officers are: Joseph E. Wright, president; Charles E. Fisher, vice president; Horace Whittier, secretary; and Frank L. Wright, treasurer. The company will carry on a general fruit canning business.

EXPERIMENT FARM GOES TO COUNTY

State Appropriation Not Available Under Existing Conditions, and County Will Take Charge.

(Special Correspondence.)
PROVO, May 11.—At a special meeting of the board of county commissioners, held yesterday the following business was transacted:

A communication was received from C. S. Tingey of the state board of examiners to the effect that as the conditions on which the \$5,000 appropriation was made to the agricultural college experiment farm at Lehi was made could not be complied with the county would better take the farm over and work it this year in order to save the trees and improvements, and trust to the future for more favorable conditions, and the probability of conditions being lived up to before another legislative session. If the conditions cannot be lived up to then the intention is that the county can take the farm. This is the farm which was purchased by the county at an expense to the county of \$10,000 on the strength of the promise of Lehi citizens to furnish the water which, it seems, they are not able to do. Arrangements will be made for a meeting with the board of examiners with a view to keep the farm going.

May 13 was set for a special meeting to appoint judges for the special state bond election, and May 20 for a special meeting for Dr. Beatty to meet with the county board of health.
