

MAYOR'S SEWER VETO

Says the Committee Have Been Arbitrarily Dealt With.

COMMISSIONERS' RESOLUTION OTHERWISE

And So Passed the Appropriation Over the Mayor's Veto.

Following is the text message of the Mayor's veto to the city council of the sewer appropriation for the year 1896.

Disapproval. The special appropriation for the sewer appropriation for the year 1896, which was passed by the city council on March 26, 1896, and which was vetoed by me on March 27, 1896, is hereby disapproved.

The reason for my veto is that the appropriation is not in accordance with the provisions of the city charter, which requires that the city council shall not appropriate money for any purpose other than the maintenance of the city's general government.
