The law governing the canvassing of the vote for Delegate to Congress, and also fixing the time in which a contest may commence, reads as follows, and I think you will agree with me that the thirty days begin to run from the time of canvassing the vote, and not from the time of isuing the certificate.

"SEC. 2.—So soon as the returns are in, the canvassing of votes shall commence, and shall be completed within two days after the Coalett A T reception of said returns, and all candidates voted for at any election may be present, either in person or Camp C C by representative, to witness said canvass."
