WILL NOT PERMIT PLAN TO OPERATE

Sheriff Emery and County Attorney Hanson Make Pointed Statements.

NO CONFERENCE HELD.

Rumor That Agreement Has Been Reached Is Denied by County Officers.

Decisive edicts have gone out from the offices of the sheriff and attorney of Salt Lake county that women who move into the recently constructed houses within the stockade will be prosecuted. A rumor spread that a conference had been held between Mayor Bransford and the other two officials named, and that an understanding had been reached to the effect that the proposed scheme of the Citizens' Investment company to mass the women of the under world into new quarters on the west side of town would not be interfered with. Prompt denials were forthcoming from Sheriff Emery and County Atty. Hanson that they had entered into any such agreement. This is what Mr. Emery had to say regarding the stockade proposition:

"It is not true. I have said before that if any woman attempted to carry on an illegal business within the stockade that I would have her arrested at once. I reiterate that statement. I will not compromise with promoters of the red light scheme, denying at the same time that he had talked with the city's executive. He said:

"That is preposterous and there is not a word of truth in it. In the first place I never had a meeting with the mayor and Sheriff Emery. I have not talked to the sheriff alone or with the mayor alone, or with both on the subject of the stockade. I will abide by my oath of office and take action against any or all who may come within the pale of the law when I am called upon to do so. In this red light business I will not compromise. Cases that are brought to my notice regardless of who is interested. You cannot be too emphatic in your denial of the rumor you mention."

GOVERNMENT SURVEY CORNERS. In future all township, section and quarter-section corners of government surveys will be marked by iron posts, rather than wood or stone. For the

first, the stake is to be three inches in diameter, with a brass cap on which notice will be inscribed descriptions.
