THE MORMON QUESTION AGAIN.

We are more than ever convinced that Judge McKean, who occupies the place of one whose business it is to administer law according to its true intent, is as confirmed a bigot as any Mormon he desires to persecute; that he is utterly wanting in sagacity or knowledge of law; that his purpose is to complicate difficulties where none need to exist; and that he ought to be driven ignominiously from the bench. His whole course as Judge, since the prosecution of the leading Mormons began, has been that of a narrow-minded zealot, as ignorant of law as he is reckless of the consequences of his extrajudicial acts. He started out, not to investigate, but to convict. All his utterances and his whole conduct have shown the animus of the man from first to last. He exhibits the worst qualities of a fanatic, and it is almost safe to say, from his doings, that he is a religious bigot of some sort, and is better fitted to perform the part of a wandering dervish than to sit in judgment where the liberty of one of an opposing creed is at stake.

What is it that this man and his confederates propose to do? We have shown that they are arraigning men under a law which has no applicability in the cases at bar; that they are giving a construction to an act which it will not bear. It appears that the council for the prisoners took the same ground that the Union did in advance, of the inapplicability of the Territorial law under which they are held. The Judge intimates that it does not make any difference what the meaning or intention of the statute was at the time it was passed! His object is to procure a conviction by a perversion of the statute, which, as a sworn Judge, he is obliged to interpret according to its true intent, and not to gratify his religious prejudices and personal malice. We are informed that the Federal officials are acting wholly without authority or advice from Washington. They are indulging in the pastime of small men, dressed in a little brief authority, in order to feed vanity, exhibit power and make a noise.

The consequence of the course of these blind zealots or designing mischief makers are bound to be evil. Thousands of children, innocent as any on the earth, will be made bastards and deprived of their patrimony by the ill-timed action of the Federal officials. And what good will be attained? Why the Mormon polygamists will be thrown into prison. That will be full compensation for all the trouble taken. A little sweet revenge will be grateful—that is all. The confederates in this affair do not take into consideration that polygamy was dying out and in the course of rapid extinction, and that the forced process to which they have resorted will give it a new lease of life, as well as involve other consequences. There was an opportunity to show themselves, and they could not resist the temptation to make an unseemly exhibition.

We have it on good authority that some of these conspirators at Salt Lake admit that they are resorting to foul means, and chuckle over the effects they are going to produce. This is not the spirit that should actuate men invested with the power of dispensing impartial justice according to the real meaning of the laws. If there were a statute of the United States under which these polygamous Mormons could be punished, we should say, under the circumstances, that it was not wisely enacted. A judge is not to be held responsible to the bar of public opinion for acts done under the authority of law, but the Utah Judge has felt no such pressure. His course is not sanctioned by popular sentiment among the people of Salt Lake who have no sympathy with the peculiar institutions of the Mormons. The conspirators are striking a blow at progress by repelling capital and population, and continuing polygamy instead of abating it.—*Sacramento Union.*
