In 1851 he was appointed president of the Birmingham Conference, where he labored faithfully until released to emigrate to Zion, in 1854. He was ordained a Bishop about twenty years ago, and presided over the southern portion of Summit County for four or five years, after which he presided over the Peoa Ward up to the time of his death. He died in full faith of the gospel. He was a kind husband and an affectionate father. He leaves a wife and a large family, and numerous friends to mourn his loss.
