DIED.

CURTIS—At Payson, U. T., Aug. 1st, 1883. Joseph Curtis, aged 64 years, 7 months and 7 days.

He was a son of Nahum and Millicent Curtis, born December 24th, 1818, in Oneonta, Erie County, Pennsylvania. He became a member of the Church of Jesus Christ of Latter-day Saints April 16, 1833 being baptized by Elder Almon Barbee in the State of Michigan. He gathered with his father's family to Clay County, Missouri, in June, 1836, and from that date was identified with the Saints in all the persecutions, mabbings and drivings which they have endured. He filled several preaching missions through the Eastern and Northern States. Was on a mission in the State of Michigan, when Joseph and Hyrum Smith were martyred. Was married to Sally Ann Reed, January 1, 1846, by whom he raised a large family of children when the Saints were driven from Nauvoo; he volunteered as one of the Pioneers to seek a home for the Saints in the Rocky Mountains. Was released, however from that mission on account of the death of his father. He reached Salt Lake Valley, Oct. 12, 1848. In December, 1850, he came to Payson, then called Pocatoot, being the fifth family to locate here. He was soon after set apart as Second Counselor to Bishop Cross, of this Ward, and at the death of Bishop Cross was retained as Counselor to Bishop C. B. Hancock. Brother Curtis was an active, zealous and consistent member of the Church, foremost in every good word and work, and had the universal love and respect of all who knew him. At the time of his death he was President of the 4th district of this Ward. His funeral was largely attended, suitable remarks being made by Elders D. Lant, I. M. Coombs and H. W. Nelsbitt, and also Bishop C. D. Evans and J. S. Tanner.

OLEENSHAW.—In the Twenty-first Ward, Salt Lake City, August 13th, 1883, of hernia, Timothy Olorenshaw, born in Thurleston, Warwick, England, July 13th, 1831; baptized a member of the Church of Jesus Christ of Latter-day Saints in May, 1847, emigrated to Utah in 1872; died in full faith of the Gospel. The funeral services took place last evening, in the Twenty-first Ward Meetinghouse.
