Last Night's Dispatches.

EASTERN.

\$14,000 On Short Time.

FALL RIVER, Mass., 30.—Thirty-seven mills are in this city, after Tuesday next will run but four days each week, and eight mills will stop. The remaining two mills have a November contract. These mills employ 14,000 operatives, and their monthly pay rolls, when in full operation, is about \$600,000.

No Sale of Cold.

WASHINGTON, 30.—There will be no sale of gold or purchase of bonds by the Treasury Department next month.

Another Telegraphic Mistake.

A telegram published in the Tuesday morning papers, announcing that from three to four hundred mechanics and about one thousand laborers had been discharged from the Washington navy yard within the last two weeks, is an error, as portion of it having been omitted in transmission. The discharge alluded to was by the contractors of the Board of Public Works and probably not more than twenty-five or thirty of all classes have been discharged from the Washington navy yard.

Recruits for New Mexico.

The Superintendent general of the recruiting service has been directed to send a hundred recruits to Fort Union, New Mexico.

Failures.

New YORK, 30.—Hoyt, Sprague & Co. say they have no news of their affairs to make public just yet.

The creditors and friends of the firm are in council, and it is expected that the extension necessary will be given.

The temporary suspension of C. Millman Schmidt & Co. has taken place; the firm is in the produce-export trade. The suspension is said to be of a serious nature. A great amount of goods and grain had been shipped. Every bill which drafts were drawn, it was impossible to obtain money upon them, and consequently it became necessary for the firm to suspend payment.

Detectives on Trial.

In the trial of officers Irving and Parker, the defense of the officers against whom he has been prepared by chief clerk Hawley. They relate that McDonald, being in their custody, delivered to them a package containing \$17,000 dollars in gold, \$10,000 in silver, \$5,000, and a diamond ring, valued at \$400, with the express understanding that they were to be used for the defense of the officers and the circumference of this understanding they re-delivered six thousand dollars worth of bonds to McDonald, having good grounds for believing and knowing that the bonds were of the Royal Bank of England. It is also related that these officers were in communication with McDonald by mail and telegraph, and had entered into a compact to defraud the Royal Bank of England, and to fix the date of the trial. After argument of counsel, the specifications were amended, and testimony taken.

Lawsuit.

The suit of Wm. E. Britton, against Benj. F. Butler, to recover \$15,000, brought in the district court by Butler in 1862, while he was military governor of New Orleans, came up to day, before Judge Woodruff, in the U. S. circuit court.

Confirmed.

The board of assistant aldermen have confirmed the appropriation of \$50,000, made by the board of aldermen for the relief of Memphis.

20,000 Girls Out of Employment.

One of the effects of the panic was that growing out of employment of less than 20,000 girls from the different factories at Newark, N. J.

The Fenton Zinc Works discharged thirty hands to-day.

Union Trust Company.

A meeting of the trustees of the Union Trust Company was held yesterday, and it was decided to increase the capital and surplus with considerable surplus.

The present officers and committee tendered their resignation, with a view to reorganizing the stockholders to increase the capital stock to two millions. The new stock is to be offered to the present stockholders to Nov. 15th, to an amount equal to that now held by each.

Twenty-five per cent. premium will be paid to the stockholders.
