The Coal Famine in England.

Some persons who have heard of the present price of coal have imagined that coal itself was scarce; not only scarce in the market, which no doubt it has been, but also in the mine also. But this is a misconception. The commissioners in 1870 reported that there was 145,450,000 tons of coal which might reasonably be expected to be available for exportation. The amount of annual consumption was in 1869 a little over 100,000,000, we have plainly enough coal in the mine for many years. What has happened in the coal trade, though very important, is simple. The demand is well known, almost unusual demand for coal—a demand greatly in excess of the usual supply. The prices consequently rose rapidly. A large number of laborers were the employers—the coal-owners were getting very unusual profits and becoming rapidly very rich, and they naturally thought that as their labor brought out the coal, they were entitled to share largely in the profits, and they thought, also, that by striking they could exact a rise of wages, and so obtain that share. The strikes reduced the quantity of coal in the markets, and the consequent increase in the price. At first sight that rise might seem not only great but extravagant. But not so if we examine it. Coal is for many purposes an absolute necessity, and it is a family peculiarity of the English that they will charge what the fare is collected on the train.
