"Dr. Snook" of Mexico Proves Himself an Accomplished Swindler.

A BREAK IN THE ANIMAL KINGDOM.

Crucial Case of Wife Desertion—Arrested for a Murder Committed Over Fourteen Years Ago.

George F. Wood took to Yuma, Colo., and placed in exhibition one of the most beautiful specimens of the animal kingdom. It is a calf three days old and heavy and lively as a cricket, that has a double front leg, four eyes and four ears. The little fellow eats with both mouths, because from both sets of nostrils, nose with all four eyes and four ears. A cloud burst somewhere northwest of Hills, Colo., just before sundown on Wednesday and Thursday, was the cause of the government work of Hills creek, overflowing it to all directions. Dr. Snook of Mexico, alias the Hon. Clayton H. Clark of Nevada, alias plain "Columbo" Snook, was arrested at Denver on Wednesday and lodged in the penitentiary. Snook is accused of being a swindler. He was apprehended on a warrant sworn out by manager Henshaw of the Brown Hotel. Dr. Snook wears a silk hat, a light suit and patent leather. He arrived in all appearance in the city last Thursday and secured a room at the Brown hotel without putting up any cash by representing that he was a mining king from Mexico and expected big remuneration. Snook soon found congenial friends, and in a very few days twenty bottles of good champagne were charged to his account. On Wednesday morning he returned very late and the hotel furnished cash. Snook said he had been robbed of a check for \$25,000, but this did not go and he had himself to jail.

A case of desertion was reported to the police at Sacramento, Cal., on Wednesday. About five years ago a young woman arrived here from Nevada and subsequently went for her lover, Andrew Larson, to whom she was engaged to be married. She was unable to keep his promise of marriage and skipped out with a girl friend of her constructive trust. She followed them to San Francisco, and after considerable persuasion succeeded in influencing Larson to return to her. They were subsequently married and resided at a hotel. Since their marriage it is claimed Larson has repeatedly announced his intention of deserting her. During the last week Mrs. Larson suspected that her husband was not friendly with a young woman named Nellie Lester and she went to investigate. She found that Larson had been frequently seen with the woman, but when she accused him of it he emphatically denied the charge. About a week ago she suddenly disappeared and investigation revealed that he had eloped with Miss Lester. It is believed that they have gone to San Francisco. Mrs. Larson is frantic with grief over her husband's desertion and it is feared she will lose her mind.

A few weeks ago a horse stealing family, consisting of Amy Marie, wife and two sons, were arrested at Huntington, Colo., and on the preliminary trial the old man and two sons were held to the district court. They were taken to the city jail for safe keeping, while Mrs. Marie was allowed to go on her parole. On Wednesday she returned with her two boys and without exciting any suspicion, hid them within a few yards of the jail. She then returned to her room to await developments. About 7 o'clock George Lyons, acting deputy sheriff, went to the jail with a posse of five men. He was looking for the cell door he entered and was promptly knocked down. The boys then ran away. The door again looked upon by Lyons, together with the old man. The two boys were quickly captured by the men and a few minutes later in a westerly direction across the prairie. The men then returned to the city and the boys were held in the city jail.
