### Archbishop Bruchesi Pastoral Letter

Montreal, April 19.—A pastoral letter rom Archbishop Bruchesi has been ead in all the Roman Catholic churches of this diocese and interesting referchees were made in it to the recent de-cision in the Delpit case and to the ac-tion of the legislature in granting to the Mount Royal cemetery the power the Mount Royal cemetery the power to cremate bodies in place of burying them, it so desired. As to the former, the archbishop merely re-states the at-titude of the church on mixed or tr-regular marriages which cannot be al-fected by the judgment of civil tribun-als and warns all communicants not to affend at the data of severe assisters. fiend at the risk of severe ecclesias ical penalties.

With respect to cremation the arch-bishop's declaration is of greater inter-cat, since he virtually censures the leg-islature for granting the request of the Mount Royal Cemetery company, which is a Protestant organization. The archbishop cited the ruling of the church on the subject quoting Pope Leo XIII's condemnation of the practice in his letter to the bishops in May, 1886, and Cardinal Richard's vigorous de-nunciation in a pastoral letter of Feb-ruary, 1890. The archbishop, after these quotations, continued: "We hesitate not to assert that the

introduction of this practice of crema-tion into our own city of Montreal is regrettable. Does the tolerance of creeds opposed to ours, or does the respect due to the freedom of worship justify it? Assuredly not since it is not included in the ritual of any church, and since it was not asked for by any religious denomination, but by a mere civil company. Does a so-called re-spect for individual liberty affect it? But who is there that does not see whither that principle must lead us? Individual liberty thus understood is a source of communism, socialism and anarchy; it is the negation of all truth, order and justice."

### MANCHURIAN QUESTION.

#### PETITIONERS' MALCONTENTS Its Latest Phase Very Differently Judged by German Papers.

### ARCHITECT THOS. LITTLE DEAD

### Was an Original Abolitionist, Teaching First Colored Sunday School.

New York, April 10 .- Thomas Little. for many years a prominent architect of this city, is dead at his home in Mount Vernon, N. Y. Mr, Little was born in York, Pa., and was in his 86th year. When a young man he was one of the original abolitionists of Penn-sylvania. He taught the first colored svivania. Sunday school in the United States in Burdentown, Pa., and was stoned because of his identification with the school. Upon coming to this city Mr. Little identified himself with the Re-publican party and was one of the delegates to the Chicago convention in 1850, when Lincoln was nominated, H was on the committee delegated to visi Lincoln at his home in Springfield and to apprise him of the action of the vention. Mr. Little was from 1857 to 1860 president of the board of supervisors of New York county.

### SHIPS UNDER CONSTRUCTION.

### Admiral Bowles Gives Summary of Per Cent of Completion.

Washington, April 10 .--- Admiral Bowles, chief of the naval bureau of construction, has given out a summary of ships under construction. It shows gratifying progress throughout all the extensive work now being carried on, the degree of completion having ad-vanced from 1 to 50 per cent on the various ships within the last month. Of the nine battleships now under contract four of them are well along, the Ill nois standing at the head and being ? per cont completed. The Maine come next, with 46 per cent completed. Tr Missouri stands 28 per cent and th Ohio 29 per cent completed. The re-maining five, the Virginia, Nebraska Georgia, New Jersey and Rhode Isiand, as well as the six armored truis ers, Pennsylvania, West Virvinia, Cait-fornia, Colorado, Maryland and South Dakota have not yet been started.

Chicago dry goods merchants say that they have heard of no efforts to get local concerns interested in the Associated Merchants' company of New York. John V. Farwell said that if the combination was attempting to interests outside of New York, he was not aware of it.

John E. Scott, of the firm of Carson, Pire. Scott & Co., said that he knew nothing about the combination except what he had read in the newspapers and that he did not believe any Chicago merchants were interested in the H. G. Selfridge, of Marshall, Field & Co., said such a combination could not affect Chicago in the least. Nor was there the slightest idea of a similar combine in Chicago.
