

LAWYER'S ASSEMBLY

The Bar Association Held Its Annual Meeting Last Night.

MUTHLAND AND ZANE SPEAK.
The Former's Advice to Young Lawyers
—The Latter's Criticism of the
Committee.

In the civil division of the Joint
Court of Justice held last evening,
no annual meeting of the State Bar
association was held. President J. G.
Zane occupied the chair and after
calling the meeting to order, he
delivered his annual address based
on "some reflections on the admission
of Utah to the Union, and some devo-
tions in the law."

PRESIDENT ZANE'S ADDRESS.

The judges in referring to Utah said
they had not been present at the meet-
ing over by the high hand of
justice, it was not because the gov-
ernor did not have the power
to do so, but rather because they did
not care to exercise that power to its
full extent. As with some chil-
dren, so with some juris-
diction, their development is nati-
ural, and, unobserved, they
will grow up to full aware-
ness of their functions; it is that they
begin to show their self-
confidence, having laid a foundation
which will bear the weight of a
responsible structure. Some day
Utah, which is undergoing a
long period of territorial vaca-
tion, will become a great power
in the Union, and under the
guidance of all the good men
and women of all the
states, Utah will change
from a state of comparative
ignorance and backwardness
to a state of freedom and
prosperity.
