chant about 10 years. His friends
said that Marchant endeavored to
seduce two of Samuel's daughters
while they were in this city attend-
ing school. He persisted in his ef-
forts by writing them letters. The
eldest daughter is in Mills' Insti-
tute across the bay. Samuel went
hysterically in prison, and said he
was ready to die for the man who
killed him.
