Pursuant to Section Eleven of Chapter XL (xxxx) of the Laws of the Territory of Utah, passed at the Twenty-first (21st) Session of the Legislature and the amendments thereto, the undersigned, the Collector of the County of Salt Lake, do hereby give notice to all persons by this notice that the following named persons are delinquent in the payment of Territorial, Territorial School, County, County School, and Special School Taxes, also tax added by Territorial Board of Equalization, for territorial purposes, in said county, for the year 1892, till the amount set opposite their respective names, and, unless otherwise provided, shall collect the same from the said delinquent taxpayers. I shall sell the property hereinafter described of any such delinquents in the manner prescribed by law. Said sale will begin the third Monday in December, at 12 o'clock noon, at the front door of the County Court House, and continue from day to day until the lot is exhausted.
