UTAH NATIONAL GUARD.

Two Companies Organized at Ogden
Last Evening.

General West, Adjutant General Ogden, General Powers and Adjutant General Clayton of the National Guard of Utah, and Territorial Secretary Richards, came to Ogden yesterday afternoon, and last evening, and with General Stevens and Colonel Ladd, held a very authentic meeting in the Hotel Ogden, to consider the organization of a company of cavalry and a company of light artillery.

General Ogden called the meeting to order and read the call to be transmitted to the persons entitled to receive it, the persons entitled to receive it, the call was read by General Ogden, and in less than an hour from the signing of the meeting sufficient names had been entered on the rolls for the organization of a cavalry which will be in the Army.

Later names sufficient for the organization of the company of light artillery were submitted and the recruits sworn in by General West.

The empanelling of a jury in the Van Paten murder case was the principal business transacted yesterday in the Fifth district court.
