## GERMAN ELUDES GRAFTERS.

Ogden, June 15.—The Omaha "Booster" train arrived in Ogden about 9 o'clock last evening. On board were over 100 of Nebraska's prominent public and business men, making a very representative party. At the Union depot they were met by committees of the Weber club and business men, who escorted them to the Weber club parlors, where a short time was spent in "getting acquainted." Mayor E. M. On Thursday evening over the Union Pacific, but had to wait in Ogden several hours for a train west over the Southern Pacific. While sitting at the Union depot during the evening he decided to go up into town for a walk, but as he started to go out of the waiting room two men stepped up and told him he must not go outside at that time. He being unable to speak much English, obeyed and went back to his seat and sat down. He overheard the two men say that later they would get him outside and rob him of his money, but being unable to speak English, he could not tell anyone, so decided the best thing for him to do was to get outside and make a run for some place where he could hide his money. He went out of the waiting room, and seeing the two men start out also, he dashed across Wall avenue and ran north about a half block and then back of the old post company's place, where he put his money under a rock. An officer observed him, and thinking his mind must be unbalanced, took him to the county jail, where he was locked up for the night. Being locked in the jail and his excitement made him very nervous, but yesterday afternoon Deputy Sheriff Rutledge, who speaks German, had a talk with him, and Strauss told him what he had done and asked the officer to accompany him, and he could not get out of the jail and his money, which he did after a half hour's search. The purse contained \$30 in cash and a ticket to San Francisco, which he was placed on the Southern Pacific train last evening and sent on his way rejoicing.

## DEMISE OF THOMAS BURT.

Stricken With Heart Failure While Climbing Mountain Side.

Springville, Utah, June 14.—Yesterday at 2 p. m. in the Fourth ward meetinghouse the funeral services over the remains of Thomas Burt were held. Bishop Jos. Lloyd in charge. The speakers were Elders B. F. Blanchard and Joseph E. Hall. The deceased was born Sept. 16, 1852, in Derbyshire, England, and emigrated to Utah in 1872.

On Monday, June 10, Mr. Burt, with some friends, went up Hobbie Creek canyon to look at some old mine claims, and as they proceeded up the mountain on foot Mr. Burt sank down and died without any warning, heart failure being the cause of his death. SIXTY YEARS AGO TODAY.

TUESDAY, JUNE 15, 1847.

The morning was fine but very windy. The company continued to ferry wagons over on the raft and also built two other rafts for ferrying purposes, but the wind being so high they could not get across very fast. In the afternoon they commenced driving some of the horses and cattle belonging to Mr. Crow's company over. One horse was drowned by the operation;

the rest all got safely across, but had all they could do to keep up against the strong current. By working hard, nearly 20 wagons were ferried across during the day.

It was concluded to leave several of the men at the ferry to make a boat and keep a ferry until the next company of saints came up, by which means they hoped to make enough to supply a large company with provisions.
